Crisis Management Group was set up to coordinate and monitor the assistance required by the Kandla Port Trust for restoration of the Port facilities damaged due to cyclone. The Crisis Management Group included the representatives of Ministries of Petroleum and Natural Gas, Defence, Commerce and Railways.

- (c) As Crisis Management Group is only a monitoring agency, no report is envisaged.
- (d) and (e) No, Sir. The Port operations have already commenced w.e.f. 25.6.98 with the active cooperation of the Kandla Dock Labour Board.
