THE MINISTER OF CIVIL AVIATION AND MINISTER OF TOURISM (SHRI ANANTH KUMAR): (a) and (b) Yes, Sir. Indian Airlines introduced a thrice weekly B-737 service between Delhi/Port Blair via Bhubaneshwar on 20th April, 1989. This was withdrawn from 20th November, 1989 because of poor load factor.

- (d) It is up to the airlines to provide air services to specific places depending upon the traffic demand and commercial viability subject to compliance of route dispersal guidelines issued by Government.

THE MINISTER OF CIVIL AVIATION AND MINISTER OF TOURISM (SHRI ANANTH KUMAR): (a) and (b) Complaints relating to denial of seats on confirmed ticket, ill-treatment of the passengers, refund on cancellation of tickets, loss of baggage, sudden cancellation of flights etc. are received from passengers travelling on private airlines. On receipt of such complaints comments of the concerned private airlines are obtained for examination and efforts are made to settle their grievances, wherever possible. Data on number of complaints received from the passengers of private airlines is however not maintained.
