Completion of Survey Work of Fatuha-Shekhpura Railway Line

1269. SHRI RAJO SINGH: Will the Minister of RAILWAYS be pleased to state the time by which the survey work of Fathuha-Chandi-Asthawa-Varvigha-Shekhpura railway line is likely to be completed and the construction work undertaken?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS, MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND MINISTER OF STATE IN THE MINISTRY OF PLANNING AND PROGRAMME IMPLEMENTATION (SHRI RAM NAIK): Surveys have been taken up for new BG lines from Fatua-Danapur via Dniawan & Punpun and between Daniawan-Shekhpura via Chandi, Bihar Sharif and Barbigha. These surveys are expected to be completed by June, 1999. Further consideration of the projects will be possible once the survey reports become available.

Promotions of Undeserving Officers in I.A.F.

Will the Minister of DEFENCE be pleased to state:

- (a) whether attention of the Government has been drawn to the news item captioned "The Undeserving Fly high in IAF Study" appeared in 'The Time of India' dated February 2, 1999;
 - (b) if so, the facts thereof; and
- (c) the corrective steps proposed to be taken in this regard and also to take note of such cases in the other two services where the officers have gone to courts to get justice?

THE MINISTER OF DEFENCE (SHRI GEORGE FERNANDES): (a) Yes, Sir.

- (b) An Inhouse Committee on Flight Safety was constituted by Indian Air Force to review the aircraft accidents/incidents and recommend measures to enhance flight safety in the Indian Air Force. Air Force authorities have reported that the recommendations regarding training and personnel policies have since been implemented adequately.
- (c) The system of selection for promotion in the Services is just and fair and has stood the test of time. However, occasionally some officer who does not get selected, may perceive himself to be wronged. Provisions exist for such officers to represent to the Central Government against their supersession/Annual confidential Reports, by way of Statutory Complaints or the legal process.

THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING AND MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS (SHRI MUKHTAR NAQVI): (a) DD-I and DD-II and all the other channels of Doordarshan are available throughout the country via satellite and could be received by using appropriate dish antenna system. All the districts of Madhya Pradesh are, wholly or partially, covered by the terrestrial transmitters of DD-I service functioning either in the same district or in nearby district. DD-II service is available terrestrially by a low power transmitter within its coverage range functioning at Bhopal district of M.P.

(b) and (c) Whereas a Low Power TV transmitter (DD-I) is already functioning at Bilaspur, setting up of TV projects throughout the country, including Bilaspur in Madhya Pradesh, is a continuous process which is being carried out by Prasar Bharati, Doordarshan, in a phased manner, depending on availability of resources, and interse priorities.

THE MINISTER OF DEFENCE (SHRI GEORGE FERNANDES): (a) to (c) While China does not have any base of its own near Andaman & Nicobar Islands, the Government is aware of the Chinese assistance to Myanmar in the upgradation of the Navai base at Coco Island.

The existence of radar, surveillance equipment and other such sophisticated facilities have security implications for India for which adequate and appropriate measures are being taken.
