and (b) As per extent instructions the reservation of SC/ ST is based on "Post based roster" system, replacing the earlier "vacancy based roster". In the new system. there is no concept of carry forward of post based slots meant for reserved categories. However, reservation, as due, is provided at the time of filling up of posts in accordance with the post based reservation roster.

The recommendations of the Commission are under consideration of the Government.

- (c) The total amount invested by the Government towards share capital in Air India is Rs. 153.84 crores. However, Air India had also taken foreign currency loans of Rs. 3649.21 crores towards purchase of aircraft and working capital requirements.
- (d) The total amount of interest paid on loans during the years 1995-96, 1996-97 and 1997-98 was Rs. 175.66 crores, Rs. 160.22 crores and Rs. 237.45 crores respectively.

There was a derailment of 8029 Dn Kurla-Howrah Express on 03.12.1998 between Mhasawad and Shirsoli stations in Manmad-Bhusaval section on Bhusaval Division of Central Railway.

(b) The accident occurred due to weld failure. The number of persons killed/injured in the accident are:--

Killed

Grievous injuries 13

30 Simple injuries

- (c) Yes, Sir. Statutory Inquiry is being conducted by Commissioner of Railway Safety (CRS)/Central Circle, Mumbai.
- (d) As per Preliminary Report of CRS, the accident was caused by fracture of left side rail on Down line at an Alumino-Thermic Weld in non-breathing length of Continuous Welded Track due to fatigue failure of Thermit Joint on account of detectable transverse type flaw.

CRS has categorised the accident as "failure of Railway Equipment".
