THE MINISTER OF DEFENCE (SHRI GEORGE FERNANDES): (a) to (d) Ministry of Defence and Ministry of Finance have approved the proposal to build an indigenous Air Defence Ship (ADS). The proposal is being processed for further appropriate clearance. The estimated cost of the proposed ADS along with spares would be around Rs. 1700 crores. The approximate period of construction would be 8 to 10 years after placing formal order for construction.

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS, MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND MINISTER OF STATE IN THE MINISTRY OF PLANNING AND PROGRAMME IMPLEMENTATION (SHRI RAM NAIK): (a) and (b) Tatkal reservation scheme on 2423 Guwahati-New Delhi Rajdahani Express train will be introduced as and when additional coach is available and attached in this train.

(c) and (d) Tatkal reservation scheme has already been introduced in 3046 Saraighat Express train. The introduction of this scheme on other trains will depend on the demand pattern and operational feasibilities.

Facilities to Jawans in Desert Areas

In so far as supplies, quartering and accommodation facilities are concerned, these are in line with such authorisation and scales, as are applicable to the defence personnel, posted anywhere in the country.

Advance provisioning action is taken to ensure that the deployed troops, do not face difficulties on this account.

Students Missing from Armed Forces Medical College, Pune
