(b) Afforestation and allied activities are being carried out in the State under various state plan and centrally sponsored schemes. An externally-aided Integrated Forestry Development Project, supported by Overseas Economic Cooperation Fund, Japan, is also under implementation since 1995-96.

(b) The earlier charges for the inspection of hot plates and fittings, etc. to ensure conformity of B.I.S. specifications have been revised from Rs. 20/- to Rs. 100/- on industry basis from 21.1.1999 from those prospective customers who are purchasing the hot plate from the open market.

(c) Oil Companies conduct elaborate and regular surprise checks and inspection of their LPG Distributors. Suitable action is taken against the distributors who are found indulging in various malpractice including forced sale of hot plate. The customers are free to purchase hot plate from the open market.
