Quality of Diesel

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS AND THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS (SHRI SANTOSH KUMAR GANGWAR): (a) Purity of diesel (HSD) is normally measured in terms of Sulphur content. Most of the advanced countries like USA and European countries have Sulphur specification in diesel at 0.05 weight percent maximum. In India, Public Sector Indian Refineries produce diesel strictly as per BIS specifications, which is currently 1% maximum sulphur. In four metros and the Taj Trapezium, Sulphur content in diesel is even now limited to 0.25% maximum. Most of the PSU refineries supply diesel to other places also with Sulphur content much below 1%.

(b) To Supply 0.25% Sulphur diesel throughout the country Public Sector Refineries are implementing diesel hydrosulphurization projects at various location at a cost of about Rs. 5600 crores.

The company officials cooperate with law enforcing agencies and are in regular touch with State Govt. to check adulteration. Regular inspections/ surprise checks of retail outlets are carried out by the officers of the oil marketing companies. Also special drives are being launched by the industry from time to time for checking malpractices including adulteration. With effect from 31.12.98, only pre-mixed fuel is being dispensed to two stroke vehicles as per directive of Supreme Court.
