telling, share market information, Job consultation etc. The service provider is allotted a PRM service (3 to 5 digits) by the Network operator (DoT) and that number can be accessed from any point in the network. For this service, the call chagers will be at a higher rate (these charges will be borne by calling users) i.e. premium rate and the revenue earned is shared between the information provider and the network provider (DoT).

3. Virtual card calling (VCC):

Written Answers

This service allows a VCC user to make a call from any telephone to any destination through Intelligent Network by using virtual card. The user is given an Account Number and a Personal Identification Number (PIN). The user invokes the service by dialling account number and his pin. After authentication by SSP, the user is allowed to dial any destination; local, national or international depending on the type of the card. The advantage in this service is that the subscriber need not be a telephone subscriber and need not carry cash for making calls.

With the addition of above features, the quality of service will improve. The subscribers will be benefitted as detailed above.
