Linking of State Capitals with Delhi by Rail

1443. SHRI NRIPEN GOSWAMI: Will the Minister of RAILWAYS be pleased to state:

- (a) whether the State capitals of the North-Eastern States have not been linked with Delhi by Rall; and
 - (b) if so, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS, MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND MINISTER OF STATE IN THE MINISTRY OF PLANNING AND PROGRAMME IMPLEMENTATION (SHRI RAM NAIK): (a) and (b) Yes, Sir. Only Guwahati, the capital of Assam is linked with Delhi by rail. Regarding other North Eastern States, construction of Rallway line from Kurnarghat to Agartala, the capital of Tripura and from Harmuti to Itanagar, the capital of Arunachal Pradesh has already been taken up. All clearances have been received for construction of new line from Diphu to Karong as the first phase of the rail link to Imphal, the capital of Manipur and Gauge conversion of line from Katakhal to Baraibhi as the first phase of line to Sairong/Aizawi, the capital of Mizoram and work is being started on these projects. Further phases would be considered in the coming years. A survey for construction of a rail line to Gangtok, the capital of Sikkim has been sanctioned. Further consideration of the project will be possible once the survey report becomes available. Rail links to the capitals of Meghalaya and Nagaland would be considered during the coming years.

Raytheon Radar

1444. DR. ULHAS VASUDEO PATIL: Will the Minister of CIVIL AVIATION be pleased to state:

- (a) whether in spite of doubts about the performance of Raytheon Radar expressed by Air Traffic Controllers (ATCs), the radar has been put into operation;

THE MINISTER OF CIVIL AVIATION AND MINISTER OF TOURISM (SHRI ANANTH KUMAR): (a) to (d) The new radar system was made operational from 11th January, 1999 after carrying out various tests including System Site Acceptance Test (SSAT), Shake down test, and running the system for shadow operations. There were some teething problem inherent in the commissioning of a new project and these have been taken care of. However, any malfunction which is noticed, will be attended to by the trained technical personnel cf Airports Authority of India as well as that of M/s. Raytheon as per the system of warranty for the equipments.
