THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS, MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND MINISTER OF STATE IN THE MINISTRY OF PLANNING AND PROGRAMME IMPLEMENTATION (SHRI RAM NAIK): (a) The Long Term Action Plan for development of undivided districts of Koraput, Bolangir and Kalahandi (KBK) in Orissa was launched in 1995. However, in order to focus on high priority schemes which would deal with the basic problems of these districts, the Government of Orissa was asked to prepare a revised plan. The Revised Long

Term Plan (1998-99 to 2006-07) consists of Central Plan and Centrally Sponsored Schemes in various sectors, namely agriculture, horticulture, watershed development, afforestation, irrigation, health, drinking water, emergency feeding, welfare of SCs/STs and rural connectivity.

(b) In addition to the normal flow of funds under Central Plans and Centrally Sponsored Schemes, various steps have been taken to ensure a certain level of funding to these districts in 1998-99. These include doubling of the first instalment of funds under Employment Assurance Scheme and provision of additionality of Rs. 37 crore in the Annual Plan 1998-99 of Orissa for these districts. Further Rs. 7 crore have been provided for Emergency Feeding Programme and Rs. 2 crore for Mobile Health Units under Basic Minimum Services.

(c) and (d) The details of the additional Central Assistance made available under the Long Term Action Plan for KBK districts from 1995-96 to 1997-98 as communicated by the State Government of Orissa is given in the attached Statement.
