THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS AND THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS (SHRI SANTOSH KUMAR GANGWAR): (a) As on 1.10.1998, 1121 retail outlet dealerships and 213 LPG distributorships were in operation in Bihar.

(b) to (d) Viable locations are included in the Retail outlet and LPG Marketing Plans of the Oil Industry. Reservation for different social objective categories is provided as under:

Scheduled Castes/Scheduled Tribes (SC/ST)	25%
Physically Handicapped Persons (PH)	5%
Paramilitary/Police/Government Personnel (PMP)	8%
Defence Personnel (DC)	8%
Freedom Fighters (FF)	2%
Outstanding Sportspersons (OSP)	2%
Open (O)	50%

Also, 33% of the dealerships/distributorships in all the categories mentioned above are reserved for Women belonging to that category. Other things being equal Unmarried women above 40 years of age without earning parents and Widows are given priority over others.

In addition to the locations pending from previous marketing plans, a total of 99 LPG distributorships have been included in the LPG Marketing Plan 1996-98, which covers most of the urban areas even small ones, including adjoining rural areas.

The selection of dealers/distributors is made through normal selection procedure of advertisement of the locations and selection by the Dealer Selection Board on merit

- (e) Locations earmarked for a particular category are filled from that category only.

## Wastage of Petrol and Diesel

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether the Government have assessed annual losses due to wastage of petrol and diesel;
  - (b) if so, the details thereof;
- (c) whether any survey has been conducted by Petroleum Conservation Research Association in this regard;
  - (d) if so, the details thereof; and
- (e) the steps being taken by the Government to check the wastage of petrol and diesel?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS AND THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS (SHRI SANTOSH KUMAR GANGWAR): (a) and (b) No, Sir. The Inter-ministerial Working Group on Utilization and Conservation of Energy 1981, however, identified an energy saving potential of 20-30% for the three sectors of Transport, Industry and Agriculture.

- (c) and (d) Yes, Sir. Petroleum Conservation Research Association had sponsored a study through Central Road Research Institute (CRRI) in 1996 to quantify fuel losses due to idling of vehicles at traffic intersections of Delhi. The per day loss of petrol and diesel was 3 lakhs and 1 lakh litres, respectively, amounting to annual loss of Rs. 245 crores.
- (e) State Governments and Union Territories have been advised to adopt the traffic engineering, education and enforcement measures recommended by the study

In addition, the National Oil Companies have sponsored a 10 km. stretch of road for synchronization of signals in the metro cities of New Delhi, Calcutta, Pune Chennai and Bangalore of which the one at Calcutta has been commissioned while the others are in progress.
