- (a) whether the Government have assessed the pitiable condition of fishermen of the coastal areas of the country, particularly the fishermen of Andhra Pradesh; and
- (b) if so, the details of schemes announced/formulated the facilities provided by the Government to the fishermen for their welfare in the country so far?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND MINISTER OF STATE IN THE MINISTRY OF WATER RESOURCES (SHRI SOMPAL):
(a) After assessing the socio-economic condition of fishermen both in coastal States as well as in inland States, the Government have been implementing Centrally Sponsored "National Welfare of Fishermen Scheme". The Scheme is presently being implemented in 17 States and 4 Union Territories including the State of Andhra Pradesh.

- (b) The National Welfare of Fishermen Scheme has three components and the details of facilities being provided by each component for the welfare of fishermen are given below:
 - (i) Group Accident Insurance Compnent: Under this component, fishermen are insured for a sum of Rs. 35,000/- in case of death or permanent disability and Rs. 17,500/- in case of partial disability. The annual premium for insurance is shared equally between the Centre and the States. In case of Union Territories, the entire premium is met by the Central Government.
 - (ii) Development of Model Fishermen Villages Component: Under this component, houses, tubewells and community halls are provided in selected villages for the fishermen and the cost is shared equally between the Centre and the State Government subject to a ceiling of Rs. 35,000/- per house, Rs. 25,000/- for a tubewell and Rs. 1,25,000/- for a community hall. In case of Union Territories, the entire cost is met by the Centre.

(iii) Saving-cum-Relief Component: This component provides financial assistance to marine fishermen during monsoon/close period. Under this component contribution of Rs. 45 per month for 8 months in a year collected from the individual and matched by the Central Government and the State Government is distributed to the fishermen in four equal monthly instalments during the monsoon/close period.

Expeditious action is taken by the Central Administrative Tribunal/Government to fill up the other vacant posts as and when they arise after following the prescribed procedure.
