However, discussions are still continuing on the size of the expanded Council, the numbers of new permanent and non-permanent members, the procedure for selecting the new permanent members and related issues such as the question of the veto.

Indo-Vietnam Agreement for use of Nuclear Power

 (a) and (b). Sir. On January 19, 1999, during the visit of Dr. R. Chidambaram, Chairman, Atomic Energy Commission (AEC) to Vietnam, a Detailed Co-operation Plan for 1999 was signed between the AEC and the Vietnam Atomic Energy Commission (VAEC). The Cooperation Plan is under the framework of the 1986 bilateral agreement between India and Vietnam for cooperation for the utilisation of atomic energy for peaceful purposes. The Cooperation Plan, *inter alia*, envisages (i) AEC assistance to VAEC in training manpower in the field of nuclear power (ii) setting up of a training centre in Vietnam (iii) exchange of scientists (iv) setting up of a

Semi-pilot Plant for manufacture, controlling and assessing the quality of UO₂ ceramics, (v) cooperation in exploration of uranium ore mines in Vietnam and (vi) visit of VAEC delegation in early 2000 to India.

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS, MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND MINISTER OF STATE IN THE MINISTRY OF PLANNING AND PROGRAMME IMPLEMENTATION (SHRI RAM NAIK): (a) to (c) A Non-lapsable Central Pool of Resources has been constituted during 1998-99 from out of unspent amount(s) from 10% of the Budget(s) of the concerned Central Ministries/Departments earmarked for the North-East and Sikkim for assisting development projects, including in the infrastructure sector, in these States.

Releases amounting to Rs. 93.10 crore, including Rs. 10.34 crore for the Leimakhong Heavy Fuel Power Project in Manipur, have been made from the Central Pool for the Projects in the North-East.

(c) Among the main reasons for the funds remaining unutilised with some of the States are:

(i) Non-release/delayed release of funds by the State Finance Department to the line department;

(ii) Carry over of large unspent balance as a result thereof;

(iii) Natural calamities like flood, cyclone etc. in the State which delayed implementation;
