## Assistance to the Unemployed Youths

## 56. > SHRI MOHAMMAD ALI ASHRAF FATMI : SHRI DAROGA PRASAD SAROJ:

Will the Minister of RURAL AREAS AND EMPLOYMENT be pleased to state :

- (a) whether the Government are extending financial assistance to the unemployed youths to provide them self-employment opportunities in rural areas:
- (b) if so, the funds granted to the States duringthe last three years; and
- (c) the steps taken to make this scheme successful?

THE MINISTER OF STATE OF THE MINISTRY OF RURAL AREAS AND EMPLOYMENT (SHRI BABAGOUDA PATIL): (a) Yes, Sir. Rural families below the poverty line are assisted under Integrated Rural Development Programme (IRDP) with a view to providing them with self-employment through income generating activities. The rural poor are provided with productive assets in the shape of term credit from banks and subsidy from Government.

(b) Funds granted to the States during the last three years are as follows:

- (c) Following steps have been taken by the Government to make the scheme successful:
  - (i) Fixation of higher investment targets per family.
  - (ii) Measures to mobilise credit through fixation of credit targets.
  - (iii) Higher subsidy limit of Rs. 7,500 for educated unemployed trained youth has been fixed.
  - (iv) Enhancement of ceiling limit for expenditure on infrastructure from 10% to 20% (25% in case of North-Eastern States).
  - (v) Introduction of back-ended subsidy.

- (vi) Extension of Cash Disbursement Scheme to all the blocks in the country.
- (vii) Enhancement of subsidy limit for group activities to Rs. 1.25 lakhs per group or 50% of the project cost whichever is less.
