To achieve this objective, the State Government has constituted a Sub-Committee of Ministers of Revenue, Law, Finance and Tourism to whole issue and make examine the recommendations. Meanwhile, a social interaction programme has been initiated under which groups of migrants have visited various districts of the Valley wherein they have interacted with the locals with a view to paving the way for the return of the migrants.

(e) The Jammu & Kashmir Liberation Front has been banned by the Central Government under section 3 of the Unlawful Activities (Prevention) Act, 1967.

- (i) Concurrent Evaluation of Integrated Rural Development Programme (IRDP) (5th round) from July, 1995 to June, 1996.
- (ii) Employment Generation Programme in KBK districts of Orissa (March 1997 to June, 1997).
- (iii) Impact Analysis of Indira Awaas Yojana (IAY) & Million Wells Scheme (MWS) (Feb. 1997 to August, 1997)
- (iv) Impact Assessment of Wage Employment Programme in selected rural areas of India (Feb. 1998 to Sept. 1998).

Concurrent Evaluation in respect of Indira Awaas Yojana (IAY) and Million Wells Scheme (MWS) is currently in progress in all the districts in the country where these schemes are implemented. These studies cover beneficiaries also.

ADVANI) : (a) and (b) With a view to tackling the problem of terrorism in Jammu & Kashmir, the Government have adopted a multipronged approach which includes, interalia, strengthening the border management, neutralising plans of militants by proactive action against them in the hinterland, gearing up intelligence machinery, galvanising development programmes and deepening of the democratic process, etc. Due to sustained pressure and concerted actions of the Security Forces and the State Administration, the number of militancy related incidents has decreased in the State and particularly in the Valley. The total number of militants killed in J&K from 1st June 1998 to 31st January 1999 is 812. There has been a significant improvement in the situation, though terrorism in J&K, which is Pak sponsored, continues to require sustained and systematic efforts to tackle it. 6 ina.

There is no Centrally sponsored scheme under which Union Government could provide assistance for the above projects. Therefore, the State Government has been advised to explore the possibility of obtaining a loan assistance from the HUDCO.
