Central Warehousing Corporation

113. SHRI JAGDAMBI PRASAD YADAV : Will the Minister of FOOD AND CONSUMER AFFAIRS be pleased to state :

(a) the location-wise number of warehouses of the Central Warehousing Corporation at present;

(b) whether the Government propose to make the Public Distribution System more effective in the country; and

(c) the location-wise number of warehouses proposed to be constructed in various States and the time by which these are likely to be constructed?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD AND CONSUMER AFFAIRS (SHRI SATYA PAL SINGH YADAV) : (a) The details of C.W.C. Warehouses in the country are indicated as statement-I.

(b) Yes Sir. Under the plan scheme for strengthening the PDS the Central Govt. provide the financial assistance to State Govts. UTs in the form of 50% Grant-in-aid and 50% Loan for construction of small godowns upto 2000 MT capacity specially in remote/inaccessible/backward/hilly areas of the country.

(c) CWC proposes to construct 1.89 lakh MT capacity in various states during 1999-2000, the details of which are indicated as statement-II.
