On the request of Ministry of Home Affairs, Special Secretary (Internal Security), Ministry of Home Affairs was appointed as Member of the Committee in place of Secretary (Border Management), Ministry of Home Affairs. In pursuance to the decision taken in the first meeting of the High Level Committee held on 15.11.2017, Chief Secretary, Government of West Bengal was co-opted as Member of the Committee. In accordance with the decision taken in the second meeting of the High Level Committee held on 29.1.2018, Dr. Amarjeet Singh, former Secretary, Ministry of Water Resources, River Development & Ganga Rejuvenation and Chairperson, Inland Waterways Authority of India, were co-opted as special invitees to the Committee.

The Terms of Reference of the committee are as under:-

- i) Appraisal of existing mechanism/institutional arrangements for management of water resources of the North Eastern Region.
- ii) Identification of gaps in the existing mechanism/institutional arrangements for optimum management of water resources of the North Eastern Region.
- iii) Suggest policy interventions required for optimally harnessing the water resources for accelerating development in the North Eastern Region.
- iv) Spelling out of actionable measures required for optimizing the management of water resources in the North East.
- v) Chalking out a Plan of Action for dovetailing of schemes/programmes of concerned Union Ministries, their attached offices & autonomous bodies as well as the schemes of the respective North Eastern State Governments.
