#### **DEATHS DUE TO GENDER BIAS**

#### 252. SHRI JITENDRA CHAUDHURY:

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) whether according to a Lancet report, about 2.39 lakh girls below the age of five die due to neglect linked to gender based discrimination and if so, the details thereof;
- (b) whether the report has also stated that 22 per cent of the overall mortality burden of young girls in India is attributable to gender bias and if so, the details thereof;
- (c) whether the study has further revealed that Uttar Pradesh, Bihar, Rajasthan and Madhya Pradesh accounted for more than 70 per cent of avoidable deaths in the country and if so, the details thereof during the last three years, State/ UT-wise; and
- (d) the action taken by the Government in this regard?

## STATEMENT REFERRED TO IN THE REPLY OF LOK SABHA STARRED QUESTION NO. 252 FOR 28.12.2018 RAISED BY SHRI JITENDRA CHAUDHURY REGARDING 'DEATHS DUE TO GENDER BIAS''

(a) to (d): No information is available in this Ministry regarding Lancet report. However, as per the information received from Ministry of Health and Family Welfare about mortality rate and steps taken by the Ministry to reduce the mortality rate are as under:

As per Sample Registration System (SRS) 2016, U5MR of India is 39 per 1,000 live births. However, mortality for girl child was 41 whereas, that for male child is 37. In 2011 U5MR was 55. Mortality for girl child was 59 whereas, that for male child was 51. There has been 18 points decline in girl child mortality as against 14 points decline in male child mortality. Thus gender gap has decreased from 8 points in 2011 to 4 points in 2016. Details as given below.

State-wise trend of Infant Mortality Rate (IMR) per 1000 live births placed as annexure at **Annexure-1**.

To reduce Under 5 Mortality, various programmes and schemes under National Health Mission are being implemented by States/ UTs and the Central government recommends financial assistance to States/ UTs based on proposals received in their Annual Program Implementation Plan (APIP).

- (1) Promotion of Institutional deliveries through cash incentive under Janani SurakshaYojana (JSY) and Janani Shishu Suraksha Karyakaram (JSSK) which entitles all pregnant women delivering in public health institutions to absolutely free ante-natal check-ups, delivery including Caesarean section, post-natal care and treatment of sick infants till one year of age.
- (2) Strengthening of delivery points for providing comprehensive and quality Reproductive, Maternal, Newborn, Child and Adolescent Health (RMNCH+A) Services, ensuring essential newborn care at all delivery points, establishment of Special Newborn Care Units (SNCU), Newborn Stabilization Units (NBSU) and Kangaroo Mother Care (KMC) units for care of sick and small babies. Home Based Newborn Care (HBNC) and Home Based Care of Young Children (HBYC) are being provided by ASHAs to improve child rearing practices.
- (3) Early initiation and exclusive breastfeeding for first six months and appropriate Infant and Young Child Feeding (IYCF) practices are promoted in convergence with Ministry of Women and Child Development. Village Health and Nutrition Days (VHNDs) are observed for provision of maternal and child health services and creating awareness on maternal and child care including health and nutrition education. Mothers' Absolute Affection (MAA) programme for improving breastfeeding practices (Initial Breastfeeding within one hour, Exclusive Breastfeeding up to six months and complementary feeding up to two years) through mass media campaigns and capacity building of health care providers in health facilities as well as in communities.

- (4) Universal Immunization Programme (UIP) is being supported to provide vaccination to children against many life threatening diseases such as Tuberculosis, Diphtheria, Pertussis, Polio, Tetanus, Hepatitis B and Measles. "Mission Indradhanush and Intensified Mission Indradhanush" was launched to fully immunize children who are either unvaccinated or partially vaccinated; those that have not been covered during the rounds of routine immunization for various reasons.
- (5) Name based tracking of mothers and children till two years of age (Mother and Child Tracking System) is done to ensure complete antenatal, intranatal, postnatal care and complete immunization as per schedule
- (6) Rashtriya Bal Swasthya Karyakram (RBSK) for health screening, early detection of birth defects, diseases, deficiencies, development delays and early intervention services has been Operationalized to provide comprehensive care to all the children in the age group of 0-18 years in the community.
- (7) Nutrition Rehabilitation Centres (NRCs) have been set up at public health facilities to treat and manage the children with Severe Acute Malnutrition (SAM) admitted with medical complications.
- (8) Iron and folic acid (IFA) supplementation for the prevention of anaemia among the vulnerable age groups, home visits by ASHAs to promote exclusive breast feeding and promote use of ORS and Zinc for management of diarrhoea in children.
- (9) Health and nutrition education through Information, Education & Communication (IEC) and Behaviour Change Communication (BCC) to promote healthy practices and create awareness to generate demand and improve service uptake.
- (10) Capacity building of health care providers: Various trainings are being conducted to build and upgrade the skills of health care providers in basic and comprehensive obstetric care of mother during pregnancy, delivery and essential new-born care.
