GROWTH OF MSME SECTOR

2167. SHRI K.R.P. PRABAKARAN:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) whether the Micro, Small and Medium Enterprises (MSMEs) sector has been consistently registering higher growth rate than the overall growth of the industrial sector in the country during the last Five Year Plan;
- (b) if so, the details thereof along with the percentage growth rate in production, establishment of new units and employment generated during the said period, State/UT-wise;
- (c) whether the growth registered by the MSME sector is lagging behind the target fixed during the said period;
- (d) if so, the details thereof and the reasons therefor including the difficulties being faced by the MSME sector; and
- (e) the remedial steps taken by the Government to achieve the higher growth rate of MSME sector?

ANSWER

(a) to (e): Micro, Small and Medium Enterprises (MSMEs) sector registered 2.72% to 6.76% growth rate in the country during the years 2012-13 to 2016-17.

57,54,490 MSMEs were registered on Udyog Aadhaar (UA) Portal in the country as on 18.12.2018. As per the 73rd Round of National Sample Survey (NSS) (July, 2015 – June, 2016), conducted by the Ministry of Statistics & Programme Implementation, 1109.89 lakh persons were employed in unincorporated non-agricultural Micro, Small and Medium Enterprises (MSMEs) (excluding construction). The State-wise details of MSMEs registered on UA portal and MSMEs as per 73rd round of NSS are given in Annexure.

The challenges faced by MSME sector relate to the constraints of finance, market, skilled work force, technology etc. Keeping in view these constraints, the Government emphasizes the promotion of conducive ecosystem for development of MSMEs in the country. Accordingly, various programmes/schemes have been put in place with particular focus on facilitation of access to finance, skill development, infrastructure support, access to market, technology upgradation and ease of doing business.
