#### FOREIGN INVESTMENT IN FPI

#### 359. SHRI K. PARASURAMAN:

Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) whether the Government has invited foreign investment for the development of Food Processing industries across the country;
- (b) if so, the details thereof;
- (c) whether the Government has also initiated programme for setting up of medium processing units with the financial assistance of the Union Government; and
- (d) if so, the details thereof and the total number of units have been established during the last three years, State/UT-wise?

#### **ANSWER**

# THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SADHVI NIRANJAN JYOTI)

- (a) & (b): Government has allowed 100% Foreign Direct Investment (FDI) in the food processing sector through automatic route subject to applicable laws/sectoral rules/regulations/security conditions. Also, 100% FDI with Government approval for retail trading, including through e-commerce, has been allowed for food products manufactured and/or produced in India.
- (c) & (d): The Ministry of Food Processing Industries (MoFPI) is implementing a Central Sector Scheme for Creation/Expansion of Food Processing & Preservation Capacities (CEFPPC) under the Pradhan Mantri Kisan Sampada Yojana (PMKSY) for setting up/expansion of food processing units in the country. Under the scheme, grants-in-aid @ 35% of the eligible project cost is provided in General Areas and 50% of the eligible project cost in North Eastern States including Sikkim and Difficult areas including Himalayan States (Himachal Pradesh, J&K & Uttarakhand), State notified Integrated Tribal Development Project (ITDP) areas and Islands subject to a maximum of Rs.5.00 crore. The units assisted are mostly of medium size keeping in view the quantum of investment in the plant and machinery. The State-wise total 147 number of units approved for financial assistance since launching of the scheme in 2017-18 is at **Annexure**.
