STATES START-UP RANKING

Will the Minister of **COMMERCE AND INDUSTRY** be pleased to state: वाणिज्य एवं उदयोग मंत्री

- (a) whether the Government has announced States start-up ranking recently;
- (b) if so, the details thereof and the reasons therefor along with the likely benefits thereof; and
- (c) the details of the number of Start-ups started so far since the roll out of start-up yojana, State-wise?

ANSWER

वाणिज्य एवं उद्योग मंत्रालय में राज्यमंत्री (श्री सी.आर. चौधरी) THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE & INDUSTRY (SHRI C.R. CHAUDHARY)

- (a): Yes Madam, Department for Promotion of Industry and Internal Trade had announced States Startup ranking on 20th December, 2018.
- (b): The 'State Startup Ranking Framework' was spread across 7 areas of interventions with a total of 38 action points. The areas of interventions included Startup policy and implementation, incubation support, seed funding support, venture funding support, simplified regulations, ease of public procurement and awareness and outreach. The framework also provided the guidelines to support implementation of action points. The evaluation of States/UTs was based on supporting documents submitted by the State Government and feedback from Startup ecosystem components. A total of 27 States and 3 UTs participated in the exercise and the results are as follows:
 - **Best Performer:** Gujarat
 - **Top Performers:** Karantaka, Kerala, Odisha, Rajasthan
 - **Leaders:** Andhra Pradesh, Bihar, Chhattisgarh, Madhya Pradesh, Telangana
 - Aspiring Leaders: Haryana, Himachal Pradesh, Jharkhand, Uttar Pradesh, West Bengal
 - **Emerging States:** Assam, Delhi, Goa, Jammu & Kashmir, Maharashtra, Punjab, Tamil Nadu, Uttarakhand
 - **Beginners:** Chandigarh, Manipur, Mizoram, Nagaland, Puducherry, Sikkim, Tripura

The Department for Promotion of Industry and Internal Trade launched the States Startup Ranking Framework with the key objective to encourage States and Union Territories to take proactive steps towards strengthening the enabling Startup ecosystems within their jurisdictions.

The likely benefits of State Startup Ranking are as follows:

- Facilitate States to identify, learn and replicate good practices
- Help bring to fore progress made by States for promoting Startup ecosystem
- Foster competitiveness & propel the States/ UTs to work proactively
- **(c):** As on 27.01.2019 total 15,632 Startups have been recognized by Department for Promotion of Industry and Internal Trade. The State wise breakup of these startups are as below:
