IRRIGATION PROJECTS

Will the Minister of WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION be pleased to state:

- (a) whether the Government has received any proposals of irrigation projects from Madhya Pradesh and Chhattisgarh during the last two years and the current year and if so, the details and the present status thereof; and
- (b) the funds allocated to Madhya Pradesh and Chhattisgarh for irrigation purpose/projects during the said period, year-wise?

(a) & (b) Water Resources Projects are planned, funded, executed and maintained by the State Governments themselves as per their own resources and priority. In order to supplement their efforts, Government of India provides technical and financial assistance to State Governments to encourage sustainable development and efficient management of water resources through various components of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) viz. Accelerated Irrigation Benefits Programme (AIBP), PMKSY –Har Khet Ko Pani (HKKP) including Command Area Development (CAD), Surface Minor Irrigation (SMI) and Repair, Renovation and Restoration (RRR) of Water Bodies [Implemented by MoWR, RD & GR], PMKSY - Per Drop More Crop (PDMC) [Implemented by Ministry of Agriculture & Farmers Welfare] and PMKSY - Watershed Development (WD) [Implemented by Department of Land Resources].

Under PMKSY-AIBP, 14 projects (and 7 phases) of Madhya Pradesh and 3 projects of Chhattisgarh have been prioritised for completion in phases by December 2019.

The Central Assistance (CA) is released for projects under various components of PMKSY as and when eligible proposals are received from the State Governments. The funds released during the last two years and the current year under various components of PMKSY to Madhya Pradesh and Chhattisgarh are given below:
