# UNSTARRED QUESTION NO. 1255 TO BE ANSWERED ON 11.02.2019

#### SKILL DEVELOPMENT CENTRES

### 1255. SHRI ANURAG SINGH THAKUR:

Will the MINISTER of SKILL DEVELOPMENT and ENTREPRENEURSHIP be pleased to state:

- (a) the details of operational Skill Development Centres opened in the country during the last three years, State/ UT-wise;
- (b) the details of persons who have been provided employment by these Centres, State/UT-wise;
- (c) the details of the persons who have been provided certification by these Centres in Himachal Pradesh, district-wise data;
- (d) the details of the efforts made to enhance employment opportunities for those who have not received certification;
- (e) whether the persons who undertook training have been placed in alignment with the target set by the Government and if so, the details thereof; and
- (f) if not, the corrective steps taken by the Government to improve the placement scenario?

#### **ANSWER**

## MINISTER IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI DHARMENDRA PRADHAN)

(a) to (c) Under Skill India Mission, Ministry of Skill Development and Entrepreneurship is implementing a flagship scheme known as Pradhan Mantri Kaushal Vikas Yojana (PMKVY) with an objective to provide skilling to one crore people under Short Term Training (STT), Recognition of Prior Learning (RPL) and Special Project (SP) through accredited and affiliated training centers (TCs) across the country for four years i.e. 2016-2020. Under the scheme, the accreditation and affiliation of training centres are being done through a single window application SMART for imparting skill development training.

PMKVY 2016-20 does not mandate the establishment of skill development centres, however, enables large number of prospective youth for taking up Short Term Training (STT) and Recognition of Prior Learning (RPL) through accredited and affiliated training centers (TCs) throughout the country including State of Himachal Pradesh. Under the scheme, for imparting the skill training, the accreditation and affiliation of TCs are being done under single window IT application known as SMART. As on 24.01.2019, 10,355 TCs (8,331 TCs under CSCM and 2,024 TCs under CSSM) have been empanelled under PMKVY 2016-20. Also, under PMKVY 2016-20, as on 24.01.2019, 37.32 lakh (appx.)

candidates have been trained in the country. The State/UT - wise including State of Himachal Pradesh numbers of TCs and candidates enrolled, trained, assessed, certified, and placed under PMKVY 2016-20 (CSCM + CSSM), as on 24.01.2019, are given at **Annexure I**.

- (d) Under PMKVY 2016-20, there is a provision of re-assessment for the unsuccessful candidates.
- (e) and (f) Under PMKVY 2016-20, focus on employment has been significantly enhanced and candidates have been placed in various sectors and industries. Training Centers (TCs)/ Training Providers (TPs) are mandated to organize placement/rozgar melas every six month with the support of Sector Skill Council. Scheme also incentivizes TCs/TPs for facilitating placement of the trained candidates. Also, the reimbursement of last 20% of training cost to TCs would be made only after wage employment or self employment to 70% of the trained candidates. Additionally, post placement support of Rs. 1500 per month per trainee is applicable for special group (women candidates and persons with disability) and special areas (LWE, North East region and J&K) for 2 or 3 month post training depending on placement within or outside the district of the domicile of the candidate.

Further, under PMKVY 2016-20 scheme, placement tracking is mandatory. The placement data is reported within 90 days of certification of trained candidate. As per data reported on SDMS, as on 24.01.2019, 21.03 lakh candidates are certified under STT and SPs of PMKVY 2016-20. The number of candidates certified under STT and SPs of PMKVY 90 days prior i.e. 26.10.2018 is 19.39 lakh. Out of these candidates, as on 24.01.2019, 10.64 lakh candidates have been placed in various sectors across the country.
