FUNDS RELEASED TO HARYANA

Will the MINISTER of SKILL DEVELOPMENT and ENTREPRENEURSHIP be pleased to state:

(a) the details of the funds released to Sonepat in Haryana under various schemes of the Ministry;

(b) whether the funds released under the said schemes have been utilized under the respective schemes; and

(c) if so, the details of the schemes under which the work has been completed or is near completion and if not, the reasons therefor?

ANSWER

MINISTER IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI DHARMENDRA PRADHAN)

(a) to (c) Under Skill India Mission, Ministry of Skill Development and Entrepreneurship is implementing a flagship scheme known as Pradhan Mantri Kaushal Vikas Yojana (PMKVY) 2016-20 with an objective to provide skilling to one crore people under Short Term Training (STT), Recognition of Prior Learning (RPL) and Special Project (SP) across the country including State of Haryana for four years i.e. 2016-2020 with an outlay of 12,000 crore. PMKVY 2016-20 has two components known as Centrally Sponsored Centrally Managed (CSCM) being implemented by National Skill Development Corporation (NSDC) and Centrally Sponsored State Managed (CSSM) being implemented by State Skill Development Missions of the States/ UTs popularly known as State- Engagement Component of PMKVY (2016-20).

Under CSCM component of PMKVY 2016-20, there is no provision of State/district -wise allocation of funds. Under this component, funds are being released to NSDC which are subsequently released by NSDC on reimbursement basis at various stages of training (commencement of the training after validation, successful certification and placement) to the empanelled training providers and centres. However, under CSSM component of PMKVY 2016-20, 25% of the funds and corresponding physical targets of PMKVY 2016-20 has been allocated to the States for the implementation of scheme through State Skill Development Missions. Under this component, after evaluation of proposal received from Haryana Skill Development Mission (HSDM), Government of Haryana, Ministry has given in-principle approval of a total target of 56,036 candidates and corresponding financial allocation of Rs. 86.27 Cr. for FY 2017-20. Out of which, as on 24.01.2019, funds amounting to Rs. 21.56 Cr. has been already disbursed to State Government for the implementation of CSSM component of PMKVY across the State including Sonipat.

Further, under PMKVY 2016-20, as on 24.01.2019, 2.76 lakh candidates have been trained under STT, RPL and Special Project in the State of Haryana in various sectors.
