#### **FACILITIES TO POOR UNDER DAY-NULM**

Will the Minister of Housing & Urban Affairs be pleased to state:-

- (a) whether the Government is providing placement oriented skill training, subsidized loans for self-employment ventures, supporting street vendors livelihoods and establishing shelter for homeless under the Deendayal Antyodaya Yojana-National Urban Livelihoods Mission (DAY-NULM) to the poorest of the poor;
- (b) if so, the details thereof;
- (c) whether the Government proposes to conduct 'Safety Net Survey' to identify eligible Self Help Groups (SHG) members not covered under the Government programme viz. SBM(U), PMAY(U), Pradhan Mantri Ujjwala Yojana, Pradhan Mantri Jan Dhan Yojana, Pradhan Mantri Suraksha Bima Yojana, Pradhan Mantri Jeevan Jyoti Yojana and National Nutrition Mission, and if so, the details thereof;
- (d) whether the Government proposes to provide a new platform called Shehri Sahabhagita Manch for regular meeting of ULB officials with SHG federations;
- (e) if so, the facts thereof and the timeline fixed therefor; and
- (f) the success achieved so far under the DAY-NULM during the each of the last three years?

#### **ANSWER**

## THE MINISTER OF STATE (INDEPENDENT CHARGE) OF THE MINISTRY OF HOUSING AND URBAN AFFAIRS [SHRI HARDEEP SINGH PURI]

(a) & (b) Yes, Madam.

The Ministry of Housing & Urban Affairs is implementing Deendayal Antyodaya Yojana - National Urban Livelihoods Mission (DAY-NULM) to reduce poverty and vulnerability of urban poor households by enabling them to access gainful self-employment and skilled wage employment opportunities, for improvement in their livelihoods on a sustainable basis. The mission also aims to build strong grass-root level institutions of the urban poor, provide shelters equipped with essential services to the urban homeless and address livelihood concerns of the urban street vendors by facilitating access to suitable spaces, institutional credit, social security, etc.

- (c) The Ministry is organizing 'Shehri Samridhi Utsav', a fortnight of events under DAY- NULM, from 1st -15th February 2019, to extend its' outreach to the poorest of the poor and the most vulnerable, showcase the initiatives and strengthening the safety net for the beneficiaries by facilitating their access to other welfare. One of the activities during the Shehri Samridhi Utsav is to identify eligible SHG members through Safety Net Survey for linking them with various government schemes namely, Swachh Bharat Mission (U), Pradhan Mantri Awas Yojana (U), Pradhan Mantri Ujjwala Yojana, Pradhan Mantri Jan Dhan Yojana, Pradhan Mantri Suraksha Bima Yojana, Pradhan Mantri Jeevan Jyoti Yojana and National Nutrition Mission.
- (d) & (e) Shehri Sahbhagita Manch is a platform constituted in all cities implementing DAY-NULM for the federation of Self Help Groups (SHGs) to engage through meeting, at least twice in a year with the Urban Local Bodies (ULBs) systematically for betterment of SHGs and strengthening the grass-root urban democracy.
- (f) The year-wise details of beneficiaries under DAY-NULM during 2015-16, 2016-17 & 2017-18 is at Annexure.
