Title: Regarding Rafale deal negotiations.

PROF. SAUGATA ROY (DUM DUM): Madam, there is a report that the Defence Ministry had objected against the Prime Minister's Office undermining Rafale negotiations. It seems that while there was a Negotiating Committee consisting of the Deputy Chief of the Indian Air Force. The Prime Minister's Office and particularly the National Security Advisor, Shri ...

[\*] was conducting a parallel negotiation in Paris with the French people. The Defence Ministry had objected that this parallel negotiation by the Prime Minister's Office and his well-known and notorious National Security Advisor, ... \* was undermining the bargaining capacity of the Government.

**HON. SPEAKER**: Any Paper will write anything and you will raise the matter here! Is the Prime Minister nobody?

**PROF. SAUGATA ROY**: Madam, the Defence Secretary had given a note. Please listen to me, Madam. It is very serious. It concerns the national security. The Defence Secretary Said, "RM may please see. It is desirable that such discussions be avoided by the PMO as it diminishes our negotiating position seriously". So, actually it is undermining the negotiation. Rafales were ultimately bought....(*Interruptions*) Madam, please listen to me.

**HON. SPEAKER**: Any newspaper will write anything and you want to raise it here in the House.

**PROF. SAUGATA ROY**: Madam, 36 Rafael aircraft were ultimately bought for Rs.59,000 crore. The price went so high because the offset was given to ... \* owned Reliance Defence, in order to help him, by the Prime Minister Mr. Modi himself. The Modi... \*duo is destroying the defence of the country by undermining the negotiations by the Air Force. ...

(*Interruptions*) The Modi... \* duo, the triumvirate consisting of... \*– the *trimurti* – is destroying the backbone of the Defence of the country.

Now, after such a thing has happened, I just saw the hon. Defence Minister leaving because she does not want to face the House. (*Interruptions*) Please come and face the House. ...(*Interruptions*)

THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND MINISTER OF STATE IN THE MINISTRY OF WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION (SHRI ARJUN RAM MEGHWAL): She is ready to face the House. ...(Interruptions)

**PROF. SAUGATA ROY**: She is leaving the House. Let her face the House. ... (*Interruptions*)

**SHRI ARJUN RAM MEGHWAL**: She is ready to face the House. ...(*Interruptions*)

**HON. SPEAKER:** I am unable to understand as to why you are raising this matter every now and then.

**PROF. SAUGATA ROY:** Madam, the slogan 'Chowkidar Chor Hai' is resounding all over the country.

**HON. SPEAKER:** Only because some newspaper has said something, you are raising it here. This matter was discussed here for one hour.

PROF. SAUGATA ROY: This is the demand of the youth of the country. ...(Interruptions) When this whole negotiation had gone into and when the Defence Department and the Indian Air Force were negotiating the whole thing, at that time, why should the Prime Minister's Office interfere about the price? It diminishes and undermines the negotiating capacity of the Defence Negotiating Team headed by the Deputy Chief of the Indian Air Force. The Rafale is standing out to be the biggest scandal.

**HON. SPEAKER:** It is nothing like that. Kharge Ji, do you also want to say something? Ask your people to go back to their seats.

**HON. SPEAKER:** Please go to your seats. I do not understand as to why you are raising the matter every day. Any newspaper will write something and the hon. Prime Minister is responsible. You are taking the responsibility for everything. You should not take it. What is all this?

श्री मिलकार्जुन खड़गे (गुलबर्गा): मैडम स्पीकर, यह छोटी बात नहीं है या यह छोटी सी समस्या नहीं है। ... (व्यवधान)

माननीय अध्यक्ष : ये मुझे भी मालूम है।

श्री मल्लिकार्जुन खड़गे: मैडम, यह बहुत बड़ी समस्या है।

माननीय अध्यक्ष: सब डिस्कशन हो चुका है। सब एक्सप्लेनेशन हो चुका है।

श्री मिल्लकार्जुन खड़गे: आप यह नहीं कह सकते हैं कि यह पेपर में आया है। यह पहली बार नहीं है। इससे पहले भी एन. राम ने हिन्दू में फ्रंट पेज पर लिखा था।

माननीय अध्यक्ष: सब कुछ हुआ था, मगर यहां डिस्कशन भी हो चुका है।

THE MINISTER OF DEFENCE (SHRIMATI NIRMALA SITHARAMAN): Madam, I thank you very much for giving me this opportunity. If they are really concerned about this matter and they have raised this issue based on a newspaper report, I would like to point out a few things in this regard ...(Interruptions). When the newspaper itself has chosen to say or point out in detail the then Defence Secretary's comment which was meant for the attention of the then Raksha Mantri, it should have also put the reply of the Raksha Mantri which was also given in writing. If the newspaper wanted to bring the truth out, I would have thought that it was incumbent upon that newspaper to put the reply of the Raksha Mantri also on record ...(Interruptions).

The Opposition Leaders who want a reply should now know what the reply of the then Raksha Mantri, Shri Parrikar was. The then Raksha Mantri, Shri Parrikar, had very clearly said in response to the file noting of the then Defence Secretary to 'remain calm, there is nothing to worry, things are going all right'. To that extent, a detailed reply was given by the then Raksha Mantri, Shri Parrikar Ji ...(*Interruptions*).

In all fairness, it should have been the duty of the newspaper which has published this to also put it on record the comment of the Defence Secretary and that the reply given was this ...(Interruptions).

Madam Speaker, I would like to remind the House that during my reply on 4<sup>th</sup> January, 2019, I had very clearly pointed out this particular allegation also about the suspected interference by the PMO and gave a reply even on the 4<sup>th</sup> January about it that when periodically, PMO enquires about the progress of any work cannot be construed as interference ...(Interruptions).

I would like to remind the entire House what was the interference by the National Advisory Council (NAC) led by Shrimati Sonia Gandhi ...(Interruptions).

Prime Minister said yesterday playing into the hands of multinational corporations and with vested interests keeping the issue alive ...(Interruptions). They are not interested in the Indian Air Force getting powerful. They are not interested in the Indian Air Force becoming empowered. They are working to the tunes of multinational corporate warfare. They are damaging this country. I charge them with that offence ...(Interruptions).
