PROF. MADHU DANDAVATE (Rajapur): Before expressing your views, Sir, I would only request you kindly to listen to our submission in detail, because it is a very basic issue. I have this with me: firstly, I have given notice under rule 388 saying that rule 32 regarding the Question Hour be suspended, and we should proceed on to discussing the very duestion of the validity of the formation of the Government, I have with me the November, 9, 1990 Press Communique of the Rashtrapathi Bhavan. Regarding the formation of the Government, the Rashtrapati Bhavan communique said that firstly, they consulted Congress (i), whether they are prepared to form the government; then they requested the Bharatiya Janata Party leaders whether they can form the Government they requested also the Left Front, whether they could form the Govern-

ment. Then they requested the Chandra Shekhar group whether they could form the Government. And there, it is said—I will read it out for you:

> "The President enquired from Shri Chandra Shekhar if he were in a position to form a viable Government ...(Interruptions)

SHRI KAMAL NATH (Chhindwara): Is the Question Hour being suspended?

MR. SPEAKER: Mr. Kamal Nath, please sit down.

(Interruptions)

SHRI KAMAL NATH: Under what rule are you allowing him, Sir? (Interruptions)

MR. SPEAKER: Please sit down. I have called Mr. Dandavate.

PROF. SAIFUDDIN SOZ (Baramulla): I have given notice, for suspension of Question Hour. (*Interruptions*) You hear me, Sir. (*Interruptions*)

SHRI KAMAL NATH: Sir, have you suspended the Question Hour?

PROF. MADHU DANDAVATE: Shri Chandra Shekhar responded to the offer and produced evidence of support to his group from the Congress (I), AIADMK, Bahujan Samaj Party, etc. The President is satisfied *prima facie* that the group headed by Shri Chandra Shekhar with the support of other parties as mentioned above has the strength to form a viable Government. (*Interruptions*)

SHRIG.M. BANATWALLA (Ponnani): I am on a point of order. (Interruptions)

PROF. MADHU DANDAVATE: No question of point of order. (*Interruptions*) No point of order during the Question Hour. (*Interruptions*)

SHRIG.M. BUNATWALLA: Under what

rule is he speaking? (Interruptions)

PROF. MADHU DANDAVATE: There is no point of order during Question Hour only notices under Rule 388. (Interruptions) Only when the President was informed by Congress (I) and others that "we will support the Government", in other words when they were the allies of the Government, though not the participants, the Government was allowed to be formed. Today's Press carries a Press interview by the Secretary of the Congress (I), AICC, Shri V.N. Gadgil, and that says that it has appeared in the Press that the Congress had declared that "we will function as an Opposition party." Mr. Gadgil has announced that that the Congress (I) is neither an ally nor a participant in the Government. If this Congress (I) consisting of 195 members is not an ally of this Government, not talk of being a participant, in that case the very raison detre of the President inviting Shri Chandra Shekhar to form the Government falls flat. We want to discuss this and therefore the Question Hour has to be suspended and we should proceed to discuss the legality of the Government.

SHRI DINESH SINGH (Pratapgarh): Mr. Speaker, Sir, in the noise I would not quite follow that my friend Professor Dandavate was trying to say. (*Interruptions*)

PROF. VIJAY KUMAR MALHOTRA (Delhi Sadar): Now clarify. Why are you sitting quiet now?

MR. SPEAKER: Why are you provoking them?

(Interruptions)

MR SPEAKER Mr Acharia, you should give him a patient hearing

PROF MADHU DANDAVATE Shall I explain?

MR SPEAKER I will come to you

SHRI BASUDEB ACHARIA (Bankura) He should speak the truth

MR SPEAKER I have permitted Shri Dinesh Singh

SHRI DINESH SINGH If they wish to bask in the glory of having been party of a government, I have no objection But there is no provision in the Lok Sabha for a supporting party (*Interruptions*) There is no provision for a supporting party There is a ruling party and the rest are opposition parties (*Interruptions*)
