REPORT

This Report of the Committee deals with the Action Taken by the Government on the Recommendations/Observations made in their First Report (17th Lok Sabha) which was presented to Lok Sabha on 20.03.2020.

- 2. The First Report (17th Lok Sabha) dealt with delay in laying of the Annual Reports and Audited Accounts of the Bharat Broadband Network Ltd, (BBNL). In all, the Committee made 03 Observations/Recommendations in the Report. The Action Taken replies have been received from the Government in respect of all the Recommendations/Observations contained in the aforesaid Report. Accordingly, the Statement showing the action taken by the Government on the Recommendations/Observations contained in the First Report (17th Lok Sabha) is given in **Appendix.**
- 3. The Committee in their aforesaid First Report had pointed out the failure of the Ministry of Communications (Department of Telecommunications)in timely laying of the Annual Reports and Audited Accounts of BBNL for the years 2015-2016 to 2018-2019. The Ministry, in their action taken replies, has also accepted that the delay occurred due to the time taken in the finalization of Annual Accounts, obtaining approval of the documents from the AGM and getting the documents printed. The Committee feel that such kinds of reasons are well within the control of the BBNL and could have been addressed with proper planning and coordination. The Committee, however, note that the Ministry has made sincere efforts on their part, as the documents of the BBNL for years 2017-2018 and 2018-2019, received by the Ministry on 28.12.2018 and 6.12.2019 respectively, were laid on the Table of the House with minor delays. However, the documents of the BBNL for the year 2019-2020 have not been laid as yet. The Committee, therefore, recommend to the Ministry that instructions should be issued to BBNL to lay the documents for the year 2019-2020* at the earliest and also to ensure timely laying of the documents in future. The Committee would like to be informed about the efforts made by the Ministry in this regard.

The Committee note that the Ministry of Communications (Department of Telecommunications) itself has not adhered to the stipulated time frame for laying of the Annual Reports and Audited Accounts of the Bharat Broadband Networks Ltd.(BBNL), New Delhi for the years 2015-2016 to 2018-2019

Recommendation (Paragraph No 16.)

While examining reasons for delay in laying of the Annual Reports and Audited Accounts of BBNL for the years 2015-2016 and 2016-2017, the Committee was apprised that Change in Director (Finance) Selection of printing agency, transfer of Staff and proof reading process were the reasons for delay for the year 2015-2016 and Change in Accounting Policy for the year 2016-2017. These procedural matters should have been taken care of well within the stipulated time frame. The Committee note that due to remedial measures taken by the Ministry/Institute like Strengthening of accounts section, automation/customization of Tally ERP and also assurance for timely laying of the documents given by the representative of the Ministry, the Annual Report and Audited Accounts of the BBNL for the year 2017-2018 were laid on 04.01.2019 with a delay of 03 days and for the year 2018-2019 have been laid on 05.02.2020 with a delay of one month. The Committee, therefore, direct the Ministry to monitor the progress at regular intervals in order to adhere to the time schedule and to ensure that in future Annual Reports and Audited Accounts of BBNL are laid on the Table of the House within the stipulated time.

The Department has made its best efforts for laying of the Annual Report and Audited Accounts within the stipulated time i.e., by 31st December. As stated above in the reply to Observation No. 15, for the year 2017-2018, Annual Report was received in the Department on 21.12.2018 and after obtaining approval of Hon'ble MOC, the same was submitted to LSS on 28.12.2018 and the AR&AA was laid on Table of the House on 04.01.2019 i.e. on the day allocated to Department. For the year 2018-2019, Annual Report was received in the Department on 06.12.2019. Last day allocated to the Department in Winter Session 2019 of the Parliament was 11.12.2019. On 10.12.2019, Department has submitted the Annual Report to LSS for laying which could actually be laid on the Table of the House on 05.02.2020 i.e. during first week of Budget Session of the Parliament 2020. The department will endeavor to lay the Annual Reports and Audited Accounts within the stipulated time.

Recommendation (Paragraph No 17.)

If due to unavoidable reasons, the Annual Reports and Audited Accounts of the BBNL could not be laid on the Table of the House within the stipulated time, a statement explaining the reasons as to why the requisite documents could not be laid within the prescribed period should be laid on the Table of the House strictly within 30 days as recommended by the Committee in its earlier reports.

Reply of the Government

As recommended by the Committee, in case of any delay in laying of AR&AA on the Table of the House, a statement explaining the reasons will be laid on the Table of the House strictly within 30 days.
