that the States' share has been calculated at the rate of 45 per cent of the net proceeds from basic excise duties and that steps have been taken to increase the incidence of additional duty in lieu of sales tax.

- 157. Copies of notifications giving effect to the changes in customs and excise duties effective from the 17th March, 1985, will be laid on the Table of the House in due course.
- 158. I had earlier mentioned that the Budget deficit at the existing rates of taxes would be Rs. 3660 crores. The proposed tax measures, taken together with reliefs and concessions, are estimated to yield net additional revenue of Rs. 311 crores to the Centre and Rs. 132 crores to the States during 1985-This will leave an uncovered deficit of Rs. 3349 crores. This deficit is lower than that in the current year and is reasonable. I am confident that various polices and measures which we have proposed will further stimulate the economy and contribute to the welfare of the common man.
- 159. Let me end, Mr. Speaker, as I began, with the words of the late Prime Minister, Smt. Indira Gandhi: "We all have faith in new India. Let us put our shoulder to the wheel".
