SHRI R. R. BHOLE (Bombay South Central): I beg to present the Twenty-first Report (Hindi and English versions) of the Committee on the Welfare of Scheduled Castes and Scheduled Tribes on the Ministry of Home Affairs and Planning Commission-Benefits for Scheduled Castes and Scheduled Tribes in Fifth Sixth Five Year Plans.

RE. CALLING ATTENTION

MR. SPEAKER: I have to take the sense of the House on one matter. I have got a communication about this Calling Attention which I admitted for today The Home Minister is in Amritsar and he has sent a communication that he is engaged in a very important business. He requested the House that it could be taken up tomorrow.

SHRI CHANDRAJIT YADAV (Azamgarh): Mr. Mani Ram Bagri sat in the well of the House and then on your request and on Prof. Madhu Dandavate's request he went back to his seat.

At that time, perhaps the impression 1 got was that perhaps the House will pass some resolution. (Interruptions) I got the impression that perhaps we will make an effort for whatever, we will take a unanimous view, expressing our concern....

MR. SPEAKER: Your assumption is right.

SHRI CHANDRAJIT YADAV: about some people who are indulging in anti-national activities or some kind of a deliberate conspiracy to create a situation. If that is going to happen, then, I will say that before this Calling Attention is taken, you should call the leaders of all the Parties and take a view.

MR. SPEAKER: All right. We will do it. In the Business Advisory Committee meeting itself, we will do it.

DR. KARAN SINGH (Udhampur): I have a submission to make on two points. One is, instead of a Call-Attention in which only very few names have figured naturally because of the ballot, would it not be better to have a wider discussion on this?
