SHRI A. K. ROY: The Contract Labour Abolition Act defines what is the perennial nature of a job. What is the fate of the workers after departmentalisation? The Minister may clarify this firstly. Secondly, 9,000 workers of Dali Raja Hare Ore are on strike. I want an assurance whether you will take some initiative in the matter?

SHRI NARAYAN DATT TIWARI: I would like to invite you over a cup of tea to discuss this matter with me.
