STATEMENT RE: WITHDRAWL FROM CONTINGENCY FUND OF INDIA FOR THE NEWLY CONSTI-TUTED ADVISORY BOARD ON ENERGY

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI NIHAR RANJAN (Laskar): Sir, As the Hon, Members are aware, the Government of India have set up on 21st March, 1983, an Advisory Board on Energy under the Chairmanship of Shri K.C. Pant. It includes

represtantives from different energy sectors and also specialists and experts. The Board would be responsible for continuously reviewing the energy situation and propose future energy options on an intergrated and coordinated basis. The Board will assess the likely demand and availability of different forms of energy and suggest appropriate arrangements to meet the country's energy needs on an optimal basis. An important function of the Board will be to propose measures for energy conservation, energy substitution and more efficient use of different forms of energy.

- 2. The Board will be serviced by the Cabinet Secretariat. The Demand for Grants of this Secretariat for the year 1983-84 are already before the House for consideration. The expenditure on this 'New Service' could not be forseen and has not been incorporated in the Budget provisions for the year 1983-84. The Board is required to begin its work early and submit its reports. Delay in providing the funds would not be in public interest. Funds for meeting the expenditure on setting up of the Board and for meeting the day to day expenditure, viz. salary and allowances, office expenses and Travel expenses etc. have to be provided. It is accordingly proposed to withdraw Rs. 8-00 lakhs from the Contingency Fund of India and place it at the disposal of the Board.
- 3. This amount would meet the expenses of the Board up to the end of August, 1983. Expenditure on the Board will be included in the first supplementary estimates to be presented to Parliament in its next session and the advance mentioned above from the contingency fund shall be resumed to the Fund as soon as Supplementary-Appropriation Act in respect of the expenditure on the Board for the whole year is passed.
