That is nothing. I do not depend upon hearsay.

SHRI ANANTHA RAMULU MAL-LU (Nagarkurnool): I am from Andhra Pradesh. Eighty-six Harijans have become homeless in Andhra Pradesh.

MR. SPEAKER: That is a State subject.

SHRI ANANTHA RAMULU MAL-LU: That is a Harijan problem. That concerns the Harijans. Eighty-six persons have become homeless and four persons have been killed.

MR. SPEAKER: I will look into it.

SHRI ANANTHA MAMULU MAL-LU: It is a serious problem. It is a political problem. The Telugu Desam people have attacked the Congress people.

MR. SPEAKER: I will see.

SHRI NIREN GHOSH: A serious situation has been created in West Bengal because of the continuous exodus of refugees from Assam to Alipur Duar. It will create a law and order problem. The State is suffering from financial constraints. What is the Centre doing obout it to stop the inflow, as well as to care for those who have come to Alipur?

MR. SPEAKER: I have already allowed a statement under 377 on this subject. It was even mentioned the day before by the Prime Minister. She referred to it.

SHRI SATYASADHAN CHAKRA-BORTY: Now that the Prime Minister is here, I want to ask about the refugees who have crossed over to West Bengal.

MR. SPEAKER: No, not now.
