needed are coming forward to be trained and such of them as are being trained are not just enough to serve the needs of the hospitals in our country. Therefore, I would like to suggest, as has happened in Madras State, the acceptance by the Government of the scheme of recruiting male nurses, giving them training and thus increasing the total number of nurses available.

Secondly, in regard to women nurses also, their conditions of work need quite a lot of improvement, more specially in regard to security to be provided for them. We been having reports of how some of the nurses have come to be treated rather badly while in the hospitals and also in their hostels and as they were going between the hospitals and the nursing homes also. So, some improvement has got to be made in order to assure them sufficient security.

Thirdly, 'till now, these nurses have been coming from only one or two States or rather these young vomen hailing from one or two States only have been offering themselves to be trained as nurses and, afterwards, to be employed. Some special steps have to be taken by the Government to see that facilities are provided for men as well as women to be encouraged to offer themselves for being trained as nurses and for being employed as nurses also.

Lastly, some special steps will have to be taken to encourage the tribal people, tribal women specially, to come forward and offer themselves to be trained as nurses.

I hope, the hon. Minister will try to take steps in the direction suggested by me.

SHRI B. SHANKARANAND: I take note of the suggestions.

MR. DEPUTY-SPEAKER: The question is:

"That in pursuance of clause (0) of sub-section (1) of Section 3 of the Indian Nursing Council Act, 1947, the members of this House do proceed to elect, in such manner as the Speaker may direct, two members from among themselves to serve as members of the Indian Nursing Council."

## MATTERS UNDER RULE 377

(i) STEPS TO PROTECT ANANDPUR SUB-DIVISION IN ORISSA FROM RECURRING FLOODS

\*SHRI HARIHAR SOREN (Keonjhar): I would like to draw the attention of the hon. Minister of Agriculture regarding the extensive damage of crops in 30,000 acres of land in Anandpur sub-division of my constituency due to the recurring floods of river Baitarani. This area is very much prone to floods and almost every year there will be a loss of not only crops but cattle wealth as This loss will run into several lakhs of rupees. In addition, hundreds of lives are lost every due to these floods.

It is predominantly, a backward area where the people are much below the poverty line. They are constantly demanding the construction of a barrage on river Baitarani at Anandpur, so that the recurring floods can be averted. It is a vital issue as it concerns the living of millions of people.

In view of this, I urge upon the Government to sanction required funds for constructing a barrage at

Anandpur, so that the entire area can once for all be protected from the recurring floods.

- (111) that a fine of Rs. 25.00 and Rs. 10.00 each has been extracted from those who procured rations from the nearby villages;
- (iv) that as such, this community of about 250 people of weaker sections is living in terror, a state of seige and stravation and is being compelled to participate in a political agitation against the Government at gun point.
