STATEMENT RE : SITUATIONS – IN SRI LANKA

THE MINISTRY OF STATE IN THE MINISTER OF EXTERNAL AFFAIRS (SHRI NIWAS MIRDHA) : Honourable Chairman and Members of the House,

Recent developments in Sri Lanka are causing us deep concern. There have been reports of sharp deterioration in the security situation in the Northern part of Sri Lanka, resulting in largescale loss of human life and property. There have also been reports of encounters between Sri Lankan State security forces and Tamil militants. The Sri Lanka security forces have suffered some casualties. Two Naval personnel are reported to have been killed in the violence and a senior police official died in his office in a bomb explosion. Loss of Tamil lives and property have been far greater. There have been reports of large-scale arrests in the Northern province. It has been reported that the town of Velvettiturai has been extensively shelled by the Sri Lankan Navy causing very heavy loss of life and property there. A very large number of people have been rendered homeless and are accommodated in school buildings and elsewhere. These tragic happenings have caused deep agony and shock.

As the House is aware, we have repeatedly expressed our opposition to all forms of violence and have reaffirmed our support for Sri Lanka's integrity and unity. We have taken all steps to

curb any activities which may be directed against Sri Lanka from our soil. The Prime Minister has condemned the outrage at the Madras Airport on 2 August 1984, in which 29 persons died. It is, therefore, both deplorable and regrettable that responsible leaders of Sri Lanka continue to make baseless allegations against India for providing sanctuary and support to Tamil militants. I would like to reiterate once again that such false and unfouded all legations can only create undecessary misunderstanding in the relations between two the countries.

At a time when the all Partie⁸ Conference is continuing, any escalation or confrontation of this nature would only jeopardise the political dialogue going on at present. The current situation in Northern Sri Lanka is tense and disturbed and calls for concerted and sincere efforts for reconcilitation. It is our hope that greater restraint and understanding will prevail, which can bring about an atmosphere free of communal tension and conductive to the efforts of the leaders of all parties and communities in Sri Lanka to achieve a lasting political solution.

Two days ago, President Jayewardenesent a message to our Prime Minister concerning these happenings. The Prime minister has sent a reply in which she has, once again, emphasised the necesssity of the utmost restraint on the part of all concerned and determined pursuit of the political process to find a viable and acceptable solution.

SHRI K. MAYATHEVAR (Duedigril): Sir, I demand full discussion on this. We have already demanded it. You see the *Free Press* of today.

SHRI K. MAYATHEVAR : Nobody's name from Tamil Nadu is there including the Congress-I MPs. Their names are also not there. (Interruptions) The Minister has given the statement.

MR. SPEAKER : I do not know what sorts of Members we have here.

DISCUSSION RE : SITUATION ARISING OUT OF THE RE-CENT COMMUNAL RIOTS IN DIFFERENT PARTS OF THE COUNTRY-CONTD.

SHRI R.R. BHOLE (Bombay South Central): Mr. Speaker, Sir, the subject on which we are having a discussion today is a very important one from the point of view of national unity and integrity. Unless and until all the people, different communities with different religions and with different cultures who live in this country live in peace, amity and also in a friendly way, it would be difficult for our country to advance not only in the matter of development but also in the matter of unity and integrity of our country.

We have different problems in this country, the problem of Scheduled Castes who are still groaning with many handicaps and the problem to a certain extent also of the trust between Hindus and Muslims. Some Muslims are not in a position to trust others because, according to them, they are not getting what they want. At the same time, some communities think that Muslims are getting everything and some of them are thinking in a wrong way. Their eyes are in a different direction. This was the climate before we attained Independence.

It is very unfortunate that even now some people amongst us, on either side, do not each other. So far as the question of communal riots is concerned specially in Bhiwandi, in Thane and a small part of Bombay, it was not entirely a clash or a conflict between the two communities.

MR. SPEAKER : Just a minute. Wehave got to so many speakers and thee is other work that we have to do tomorrow also. So, I think, the House will agree with me that we finish this business today itself even by sitting late.

HON. MEMBERS : Yes.
