- (b) whether Government have taken note of the declining trend of production in Eastern Coalfields and Bharat Coking Coal. Limited in fixing the above target;
- (c) whether Government have also tried to streamline the distribution system and allow no accumulation at pitheads; and
- (d) if so, the details of the steps taken and the targets fixed?

THE MINISTER OF STATE IN THE DEPARTMENT OF COAL IN THE MINISTRY OF ENERGY (SHRI GARGI SHANKAR MISH-RA): (a) A production target of 133 m. t. has been fixed for 1982-83 in consultation with the Planning Commission. However, keeping in view the fact that 1982 is to be observed as the Productivity Year the coal production target is likely to be raised above this level. The production target for 1981-82 was fixed originally at 121 m. t. in consultation with the Planning Commission. However, a production of 124 m.t. is likely to be achieved during the year.

- (b) The production in ECL and BCCL has shown an upward trend since 1979-80. However, the problems faced by these two compenies have been kept in view while determining their production targets.
- (c) and (d). In order to improve the supply of coal to the consumers, the coal companies are keeping constant liaison with the Railways at the operating levels and the movement of coal by Railways is also monitored at the highest level by the Cabinet Committee on Industrial Infrastructure.

Non-availability of Eltroxin Tablets

SHRI BAPUSAHEB @2776. PARULEKAR: Will the Minister PETROLEM, CHEMICALS AND FERTILIZERS be pleased to state :

- (a) whether the Government are aware that ELTROXIN tablets, useful to cure thyroid cancer, are not available in market; and
- (b) whether Glaxo Company used to manufacture these tablets and at present the company has stopped manufacturing these tablets and if so, the reasons for the same?

THE MINISTER OF STATE IN MINISTRY OF PETRO-LEUM, CHEMICALS AND FER-TILIZERS (SHRI DALBIR SINGH): (a) and (b). My Ministry monitors the availability of drugs on the basis of reports obtained from State Drug Controllers, Zonal Offices of the Central Drugs Standard Control Organisation and complaints received from the public. Shortage of ELTROXIN tablets, produced by M/s. Glaxo Labs. were reported from a couple of places. On being asked, M/s. Glaxo have reported that they have increased the production of these tablets and rushed their supplies to the areas from where shortages were Besides, the equivalent products viz. Proloid tablets produced by M/s. Warner Hindustan and Thyroid tablets, produced by M/s. Burroughs Wellcome, have been generally available.

Statement correcting the reply to U. S. Q. No. 3211 dated 8-9-81 reg. Sale of Petrol in Andamans

THE MINISTER OF PETRO-LEUM, CHEMICALS FERTILIZERS (SHRI P. AND SHIV SHANKAR) : In reply question cited above, the monthly demand of petrol each at Diglipur, Mayabunder and Rangat in North and Middle Andamans was stated to range 50 to 60 litres at the retail price of Rs. 7.07 per litre.

On subsequent check-up it came to light that the above mentioned figures were incorrect and the correct mothly demand figures should be 200 litres to 500 litres of petrol with the price at Rs. 8.10/litre for Departments under the Andaman Administration and Rs. 8.65/litre for private consumers.

The revised reply should be as under:—

- (a) Yes, Sir. The present average monthly requirement of petrol to the tune of 200 litres for private consumers and 500 litres Government agencies at Mayabunder and in North and Middle Andamans is met through supplies by the Andaman Public Works Department because Indian Oil Corporation has no depot at these places. The selling price of petrol which is approximately Rs. 8.10/litre for departments under the Andaman Administration and Rs. 8.65/litre for private consumers is based on the Government approved rate at Port Blair actuals on transportation, storage, handling and service charges, transit loss, etc. The difference in selling price of petrol between private consumers and the Government agencies is due to levy of service charges by the Andaman Public Works Department for private consumers.
- (b) For meeting future enhanced requirements, provision has been made in the sixth five year plan for installation of storage tanks and procurement of oil tankers for transport of petroleum products in the sector Ports, Harbour and Shipping. It is expected that bulk storage and transportation will bring down the retail price.
