(i) INCIDENTS OF DACOITY, LOOTING AND MURDER IN HISSAR, HARYANA

When all kinds of attempts to draw the notice of the Railway authorities in the form of petitions, letters, deputation, failed, the local people resorted stopping agitation by trains Purulia. The situation demanded the presence of the Chairman of Railway Board and the Chief Minister of West Bengal, and the Chairman, Railway Board, assured the people that a new . fast train would be introduced between Purulia and Howrah. But the Chairman, Railway Board, has gone back on his words. Instead of introducing a new fast train, the only through-train from Chakradharpur to Howrah has been made a bit faster on paper, though not in reality by abolishing a few stoppages causing inconvenience to the people all the people have again more and those for removing resorted to agitation their grievances.
