MATTERS UNDER RULE 377

(i) SUPPLY OF MORE JUTE SEEDS FROM CENTRAL POOL TO PURNEA DISTRICT BIHAR

SHRI JAMILUR RAHMAN (Kishanganj): District Purnea is one of the districts of Bihar which produces about 20 lakh bales of jute and jute is the only cash crop and so is the backbone of the economy, of the poor cultivators of the district. I am pained to raise this matter because the requirement of the district is about 7,000 quintals for jute seed whereas only 1,700 quintals have been supplied by the Central Government Pool. It is quite insufficient to meet demands of the small cultivators; It will be appreciated that this is the high time to sow the jute seed but strangely enough no tangible steps have been taken by the Government of India to supply the requirement of the district. The non-production of jute will certainly tell upon the life of the poor people as well as the loss of foreign exchange.

I would like to request the Government to take suitable steps so that the required jute seed be supplied immediately to the cultivators of the district within a fortnight.
