## INTRODUCTION

- I, the Chairperson, Standing Committee on Labour, Textiles and Skill Development (2021-22) having been authorized by the Committee, present on their behalf this Twenty Ninth Report on Action taken by the Government on the Observations/ Recommendations of the Committee contained in their Twentieth Report (Seventeenth Lok Sabha) on 'Functioning of National Institute of Fashion Technology (NIFT)'.
- 2. The Twentieth Report was presented to Lok Sabha on  $22^{nd}$  July, 2021. and laid in Rajya Sabha on  $23^{rd}$  July, 2021. The Ministry of Textiles furnished their replies on  $14^{th}$  September, 2021 replies indicating Action Taken on the Observations/ Recommendations contained in the Twentieth Report. The Committee considered and adopted the Draft Report at their sitting held on  $10^{th}$  December, 2021.
- 3. An analysis of the action taken by the Government on the Observations/ Recommendations contained in the Twentieth Report (Seventeenth Lok Sabha) is given at Appendix-II.
- 4. For ease of reference, Observations/ Recommendations of the Committee have been printed in thick type in the body of the Report.

#### CHAPTER-I

#### REPORT

This Report deals with the action taken by the Government on the Observations/Recommendations of the Committee contained in their Twentieth Report (Seventeenth Lok Sabha) on 'Functioning of National Institute of Fashion Technology (NIFT)' relating to the Ministry of Textiles.

- 2. The Twentieth Report was presented to Lok Sabha/laid in Rajya Sabha on 22<sup>nd</sup> July, 2021. It contained 17 Observations/Recommendations. Replies of Government in respect of all the recommendations have been received and are categorized as under:-

- 3. The Committee desire that Action Taken notes in respect of Observations/Recommendations contained in Chapter I and Final Action Taken Replies in respect of the Recommendations contained in Chapter V of this Report for which interim reply has been given by the Government, be furnished to them at the earliest.
- 4. The Committee will now deal with some of their earlier Observations/ Recommendations which either require reiteration or merit further comments.

## I PROGRAMMES AND FACULTIES

## (Recommendation Para Nos. 2 & 3)

5. In their earlier report, the Committee had appreciated that NIFT Alumni occupied over 70 percent of the Managerial positions in Textile and Fashion Industry not only in India but in South East Asia and remained instrumental in shaping the future of Fashion Business. Courses offered by NIFT in the Under Graduate Bachelor of Design included Fashion, Textile, Knitwear, Accessory, Leather and Fashion Communication; Post Graduate Masters Degree include Fashion Technology, Fashion Management and Design Space; Short Duration Part Time Courses in the form of Continuing Education; Bridge

Programme, Diploma Programme and PhD Programme. It was encouraging to note that the focus of academic input of NIFT is on the top ten skills for Millennial's which inter-alia included Complex Problem Solving; Critical Thinking; Creativity; Emotional Intelligence; Judgment and Decision Making; Service Orientation; Negotiation; Cognitive Flexibility; etc. While appreciating the broad span and range of Courses offered by NIFT, the Committee were of the considered opinion that developing Cutting Edge Technologies and gaining expertise as well as super-specializations in intricate areas and aspects of fashion would undoubtedly put the Indian Fashion Industry on a level playing field for which NIFT as the pioneering Fashion Institute had an even greater role to play. The Committee, therefore, recommended that NIFT leverage and expand the courses and programmes offered as per the global standard so as to cater to the high expectations of the Nation and rise further on the Global Fashion Map.

- 6. Further, observing as many as 383 vacant posts at the level of Senior Professor, Associate Professor and Assistant Professor, the Committee in their earlier Report had exhorted the Ministry to accelerate the recruitment process.
- 7. In their Action Taken Note furnished to the Committee, the Ministry of Textiles have stated as follows:-

"The recruitment process for the post of Assistant Professor started on 4<sup>th</sup> April 2021 with a written test followed by assessment of teaching skills. A total 1609 applications were received out of which 489 were shortlisted based on the performance in written exam. These candidates appeared for the interviews from 23<sup>rd</sup> July 2021 onwards. Interviews have been completed on 18<sup>th</sup>August 2021."

8. As the Ministry have not spelt out the specific efforts made to leverage and expand the courses and programmes offered in line with the international standard, as recommended by the Committee in their earlier Report, the Committee reiterate and urge the Ministry to take prudent measures towards that direction so as to cater to the high expectations and challenges. As regards filling up the vacant faculty positions, the Committee recommend that the posts of Assistant Professor for which the interviews have been completed on 18th August, 2021 be filled without further loss of time in the best interest of the Institute. The Committee further desire that earnest efforts be made to expeditiously fill the other faculty vacancies viz. Senior/Associate Professors.

## II REPOSITORY-INDIAN TEXTILES AND CRAFTS (RTC) PROJECT

## (Recommendation Para No. 8)

9. In their Twentieth Report, the Committee had noted that the Repository – Indian Textiles and Crafts Project sought to provide a digital

platform, a virtual museum of textiles and apparels including design archives, a craft repository with individuated information on craft persons, their communities, their work processes and products, Case Studies, Research in the areas of Crafts and Textiles, Crafts Museum, Weaver Service Centers, Private Collections etc. The Committee had further observed that besides showcasing creativity and diversity of traditional Indian Textiles and offering creative resource and information services, this project would also offer an interactive platform on indigenous knowledge on textiles and crafts, research and industry trends while also providing information on new developments and current events relating to crafts, clothing and textiles. While appreciating the expected soft launch of the portal in mid 2021, the Committee had desired that the requisite wherewithal be completed well in time to achieve the intended benefits of the project. The Committee had further recommended that the portal of Textiles and Craft Repository be merged with the National Center of Textile Design to offer seamless access to learning and creative resources along with multiple information services to Researchers, Entrepreneurs, etc

10. In their Action Taken Note furnished to the Committee, the Ministry of Textiles have stated as follows:-

"The recommendations of the Parliament Committee have been noted and actions have been initiated for their implementation. The portal of Repository – Indian Textiles and Crafts (RTC) has been envisaged as an aggregator that will integrate multiple digital repositories along with that of the National Centre of Textile Design. The Repository – Indian Textiles and Crafts (RTC) portal will offer seamless access to learning and creative resources along with multiple information services to researchers, entrepreneurs, etc. The scheduled soft launch of the Repository – Indian Textiles and Crafts (RTC) portal has been delayed due to the Pandemic and has now been planned for the beginning of 2022."

11. The Committee note that the scheduled soft launch of the Repository - Indian Textiles and Crafts (RTC), which has been envisaged as an aggregator to integrate multiple digital repositories alongwith that of National Centre for Textile Design, has been delayed due to the Pandemic and has now been planned for at the beginning of 2022. The Committee impress upon the Ministry to make fervent efforts to launch the RTC portal in January, 2022 itself so that the intended seamless access to learning and creative resources alongwith multiple information services to Researchers, Entrepreneurs etc. are soon accomplished.

# III <u>INTERNATIONAL LINKAGES WITH DUAL DEGREE</u> OPPORTUNITY

## (Recommendation Para No. 11)

12. In their earlier report, the Committee had noted that Strategic Partnership of NIFT with Fashion Institute of Technology (FIT) New York, USA allowed selection of Meritorious Students from NIFT for a unique opportunity to obtain a dual degree from both NIFT and FIT wherein students from NIFT would undertake two years study at home Institute intercepted by study of one year at FIT, after which, the students would resume their studies at NIFT to obtain Dual Degree from both the Institutes. The Committee had also noted that since its inceptions in the year 2015-16 till 2019-20, the total number of outgoing students vis-avis incoming students under the programme stood at 290 and 194 respectively whereas the number of students who have been benefitted from the Dual Degree Scheme for the year 2019-20 stood at 41 (outgoing Students) and 26 (incoming students). The Committee desired that earnest efforts be made through feasibility studies to give more opportunities to larger number of students by tying up with other countries too for obtaining such unique Dual Degrees.

13. In their Action Taken Note furnished to the Committee, the Ministry of Textiles have stated as follows:-

"The academic strategy of NIFT embraces internationalism. Over the years, NIFT has consciously enhanced its international visibility and standing among other reputed fashion institutes abroad. NIFT has strategic agreements and partnerships with 26 leading international fashion institutes & organizations that share the same academic direction. The International and Domestic Linkages Department offers unique opportunities to NIFT students to integrate with the global mainstream of fashion by selecting the exchange programme with collaborating partner institutes. The exchange takes place in many forms, either for a semester or for a year as in the case of one year Associate in Applied Science (AAS)programme offered to NIFT students which offers them a Dual Degree of NIFT and FIT.

Dual Degree Programme (FIT): Strategic partnership of NIFT with Fashion Institute of Technology (FIT), New York, USA allows selection of meritorious students from NIFT for one year programme at FIT, USA which offers the exchange students a Dual Degree from both NIFT and FIT. Students from NIFT undertake two years study at the home Institute intercepted by study of one year at FIT. Thereafter, the students resume their studies at NIFT. At the end of four year undergraduate programme the students are awarded Dual Degrees from both the institutes.

Students from all Campuses belonging to the Design stream benefit from this opportunity at FIT. Looking at the success of this exchange opportunity, International and Domestic Linkages (I&DL) Unit is exploring possibilities of extending it to other disciplines. I&DL is looking at alliances with Partner Universities which will offer the Dual Degree Programmes to the students across NIFT Campuses to students belonging to Fashion Design, Technology and Management streams. Over 70 students have availed in the past & 62 have been shortlisted for this year.

In this regard dialogues are in progress with the following Universities that are keen to offer Dual Degree opportunities to NIFT students from Design, Masters in Design and Fashion Management.

1. Manchester Metropolitan University (MMU), UK

- 2. ENSAD (ENAMOMA), France
- 3. IESEG, France to Fashion Management Studies."

14. The Committee note that the International and Domestic Linkage (I&DL) Department of NIFT offers unique opportunity to the students to integrate with the global mainstream of fashion by selecting the exchange programmes with collaborating partner institutes. Strategic partnership of NIFT with Fashion Institute of Technology (FIT), New York, USA is one such effort and looking at its success, I&DL is contemplating alliance with more partner Universities abroad to offer Dual Degree Programmes to the Students belonging to Fashion Design, Technology and Management streams across the NIFT campuses. The Committee are of the considered opinion that it is a prudent measure intended by the I&DL for the benefit of the talented NIFT students and should be persisted with to enable the premier Fashion Institute to further enhance its international visibility and standing.

## IV BUDGETARY SUPPORT

## (Recommendation Para No. 15)

15. In their original report, the Committee were deeply concerned to note that NIFT used to receive various grants from the Government of

India since 1986-87 which was discontinued after 2012-13 Financial Year. Further, NIFT had not been funded to meet any revenue and administrative expenditure and no specific grant had been sanctioned for the purpose. In view of the increasing number of outputs of NIFT in terms of hosting about 3200 Graduates each academic year and keeping in mind the fact that no institution can excel without robust funding support for carrying out research and development activities, the Committee exhorted the Ministry to strive to ensure adequate financial support to NIFT enabling it to excel in its mission.

16. In their Action Taken Note furnished to the Committee, the Ministry of Textiles have stated as follows:-

"National Institute of Fashion Technology (NIFT) was set up under the Ministry of Textiles, Government of India as a statutory Institute governed by NIFT Act, 2006. NIFT, today, has spread its wing across the length and breadth of the country.

NIFT was started by the Govt. of India in 1986, however, after the year 2012-2013 no revenue grant is provided to NIFT. NIFT is meeting revenue expenditure through its internal sources i.e. fee income, interest income and research project income etc. NIFT is also involved in Research. It will be appropriate if for research in Management, Design & Technology Govt. funds are provided to have world class lab in its Campuses. Fund support is required for research work."

17. The Committee are deeply concerned to note that after the year 2012-13, no revenue grant is provided to the NIFT by

Government of India and all the revenue expenditure is met through NIFT's internal sources *i.e* fee income, interest income, research project income etc. In view of the constraints being faced by NIFT in furtherance of its research in management, design and technology related activities due to inadequate funding support, the Committee once again exhort the Ministry of Textiles to take up the matter with the Ministry of Finance to obtain requisite budgetary support for NIFT so as to enable the Institute to establish world class labs and further excel in its mission.
