REPORT

This Report of the Committee deals with the Action Taken by the Government on the

recommendations/observations made by the Committee on Papers Laid on the Table in the Thirtieth

Report (Seventeenth Lok Sabha) regarding delay in laying of the Annual Reports and Audited Accounts

of the Port Blair Municipal Council (PBMC), Port Blair, which was presented to Lok Sabha on

23.09.2020.

2. The Action Taken Notes have been received from the Government in respect of all the

recommendations/observations contained in the aforesaid report. Accordingly, the statement showing

the action taken by the Government on the recommendations/observations contained in the Thirtieth

Report are given in Appendix.

3. The Committee in their Thirtieth Report (Seventeenth Lok Sabha) had pointed out the

failure of the Ministry of Home Affairs in timely laying of the Annual Reports and Audited

Accounts of the Organisation since the year 2006-2007 and recommended that the documents of

the PBMC should be laid within the stipulated time in future.

4. The Committee appreciate that the Government has accepted all the recommendations of

the Committee made in the said report and has also taken steps for their implementation. The

Committee are, however, constrained to note that the documents for the years 2018-2019 and

2019-2020 which were required to be laid on the Table of the House within nine months from the

closure of the respective financial year have not been laid as yet, despite Committee's

directions/recommendations in the aforesaid report. While taking a serious note in the matter, the

Committee strongly expect the Government to make concerted efforts to ensure timely laying of

the documents of the PBMC in future.

STATEMENT SHOWING ACTION TAKEN ON THE RECOMMENDATION/CONCLUSION CONTAINED IN THIS THIRTIETH REPORT OF THE COMMITTEE ON PAPERS LAID ON THE TABLE.

Port Blair Municipal Council, Port Blair

(Recommendation Serial No. 13)

The Committee note with utter dismay that there has been excessive delay in laying of Annual Reports and Audit Accounts of Port Blair Municipal Council since the year 2006-2007. The Annual Reports and Audited Accounts of the PBMC for the accounting years 2006-2007 and 2007-2008 were laid on the Table of the House with delay approximately ranging from 6 to 7 years.

Reply of the Government

The point is noted and all efforts are underway to prevent recurrence of delay in the tabling of Annual reports & Audited Accounts. As of now, Audited Accounts along with the delay statement have already been laid on table of House for the period 2008-2018. For the past period i.e 2007-08 to 2017-2018, Annual reports are being prepared but scarcity of the documentation is affecting this effort.

The Committee were apprised that the cumulative factors such as not having required capacity in Accounts Department of the PBMC, Non availability of Hindi Translator, voluminous back-log of the work taken up in phased manner and Delay in entrustment of Audit to C& AG had been responsible for delay caused in timely laying of the documents. The committee, however, note that there have been undue delays at several stages which could have been very well avoided. There was already a delay of more than two years when PBMC first approached C&AG on 23.07.2010, after compilation of accounts for the years 2006-07 and 2007-08 on 30.06.2010 and 31.08.2010 respectively. Had proper planning and prompt monitoring been done, there would not have been the backlogs for the past many years i.e. from 1990-91 onwards, due to which the compilation of accounts had to be taken up in a phased manner. The Ministry of the Home Affairs and PBMC apparently failed in managing the situation. The Committee note with displeasure that due to expiry of the Entrustment of Audit by C&AG in 2005-06, the same had to be taken up afresh on 12.08.2010 by the Council which was communicated by the Ministry of Finance on 07.03.2013, and this caused considerable delay in laying of the documents.

Reply of the Government

The delay caused in the past is regretted. All efforts are underway to prevent recurrence of further delay. Annual calendar for finalizing accounts has been adopted & is being followed at present.

(Recommendation Serial No. 15)

The Committee take note that subsequently, Ministry has laid Audited Accounts of PBMC along with the delay statement for the years 2008-09 to 2013-14, 2014-15 and that for 2015-2016 and 2016-2017 in House on 08.08.2017, 19.12.2017 and 26.7.2019 respectively. However, the Audited Accounts for the year 2017-18 have been laid on the Table of the House on 04.02.2020 with delay of 13 Months and documents for the year 2018-19 have not been laid on the Table of the House as yet. The delay for these accounting years is as huge as that of 13 to 91 months. Further, the Annual Reports for the accounting years from 2008-09 to 2018-19 have not yet been laid despite of the committee emphasizing time and again that both the annual Reports and Audited Accounts of an Organization should be laid on the Table of the House simultaneously so as to enable the Members of Parliament to get a complete picture of the Government allocations, utilization thereof and activities of the Organization. The Committee are disappointed to note that the Ministry of Home affairs has failed to comply even with the specific recommendations of the Committee.

Reply of the Government

Audited Accounts along with the delay statement have been laid on the table of the House for the period 2008-2018. The audit for the accounts for financial year 2018-19 is over and report is awaited from office of C&AG. The same shall be placed on the table of the House along with the annual report as soon as it is received. All efforts are underway to prevent recurrence of further delay. For the past period i.e 2007-08 to 2017-2018, Annual reports are being prepared but scarcity of the documentation is affecting this effort.

The Committee also note that PBMC is in process of switching over to Double Entry Accounting System for streamlining the accounting process and hope that by now the computerization process would have been completed and that there would be no further delay in accounting process in future.

Reply of the Government

PBMC has implemented Double Entry Accounting system successfully. Further in order to streamline accounting process Tally on CLOUD has been implemented with integrated ePayment solution. Delays in the accounting process shall be avoided with these interventions.

The Committee also note that the PBMC has prepared Calendar for completion of its various activities so as to ensure timely submission of its documents for laying on the Table of both the Houses of Parliament to avoid delay in laying in the future. The Committee directs that the said timeline for completion of the Annual Report and Audited Accounts is strictly adhered to, to avoid any further delay.

Reply of the Government

Point noted. The calendar/timelines shall be strictly adhered to.

(Recommendation Serial No. 18)

The committee further note that there is no specific provision in the Andaman and Nicobar Islands (Municipal Board) Regulation, 1957, regarding laying of Audited Accounts and Annual Reports on the table of the House. A suitable provision in the Act is considered desirable to bring about certainty in the position.

Reply of the Government

Point noted. Proposal for incorporating the specific provision shall be moved.

(Recommendation Serial No. 19)

The Committee also impress upon the Ministry that if due to unavoidable reasons, the Annual Reports and Audited Accounts of PBMC could not be laid on the Table of the House within the stipulated time; a statement explaining the reasons as to why the requisite documents could not be laid within prescribed period should be laid on the Table of the House within 30 days or as soon as the House meets, whichever is later.

Reply of the Government

Point noted.
