the copies of the Railway Minster's speech should be distributed among the Railway officers and staff for their information and guidance. This inter alia avoided various types of misgivings in the minds of staff about the language policy of Union of India. With a view to make out adequate number of copies of Minister's speech in Hindi and English for distribution to all Railwaymen throughout the country, printing was the most appropriate means. This was printed at the Northern Railway Press, Shakurbasti and sent to Railway Administrations for distribution among the staff and officers for their information and guidance.

## Shortage of Diesel in Muzaffarnagar

- 4183. SHRI SAEED MURTAZA: Will the Minister of PETROLEUM, CHEMICALS AND FERTILIZERS be pleased to state:
- (a) whether he is aware that tractors, pumping sets, trucks and buses are not operating on account of acute shortage of petrol and diesel in muzaffarnagar. Meerut and other surrounding districts; and
- (b) if so, the efforts being made by Government in this regard?

THE MINISTER OF PETROLEUM AND CHEMICALS AND FERTILI-ZERS (SHRI H. N. BAHUGUNA):
(a) There have been problems of availability of petrol and diesel at the retail outlets in Muzaffarnagar/Meerut and other surrounding districts during the period November—December 78, due to inadequate availability of the products at the depot locations.

Main reasons for the shortfall are as follows:-

- (i) Low opening High Speed Diesel inventory at the beginning of November at Meerut and other North West depots;
- (ii) Lower crude intake at Barauni Refinery resulting in lower availability of products at Panki (Kanpur); and
  - (iii) Rail movement constraints.
- (b) Necessary steps have been taken to ensure adequate despatch of products by rail as well as road for these locations for meeting the demand.
