STATEMENT RE. FIRE IN DOOR-DARSHAN KENDRA IN SRINAGAR.

THE MINISTER OF INFORMATION AND BROADCASITNG (SHRI L.K. ADVANI): Madam Chairman, I would like to inform the House that according to information available, a fire broke out in Srinagar Television Studios at about 1.15 A.M. this morning. The fire lasted upto about 4.30 this morning. The main studio has been affected seriously by the fire and the adjoining control from and technical areas have also been damaged.

The Security Guard and the Chowkidar on duty acted immediately and the fire fighting and Police Services of the State were at the Centre within five minutes of being informed.

The Office block of Doordarshan, Srinagar was not affected by fire.

The Director General and the Chief Engineer, Doordarshan have already reached Srinagar.

Improvised arrangements are being made at the transmitter to carry on with programme transmission.

The full extent of the damage done by the fire and its cause are not yet known.
