## NINETEENTH REPORT

SHRI KANWAR LAL GUPTA (Delhi Sadar): I beg to present the Nineteenth Report (Hindi and English versions) of the Committee on Papers laid on the Table.

### STATEMENT RE. REDUCTION IN PRICES OF COTTON CLOTH AND COTTON YARN

THE MINISTER OF INDUSTRY (SHRI GEORGE FERNANDES); Sir. Government has been viewing with concern the trend of rising prices of cotton cloth and yarn in recent months. particularly in the context of the failing prices of cotton This was first brought to the notice of the industry which in its defence pointed out that while cotton prices have, no doubt, fallen, costs of other inputs like wages, dyes and chemicals, fuel and other overheads have been increasing at the same time, which has made up for the fall in prices of cotton. The industry also drew Government's attention to the power cuts which have been imposed in various parts of the country and wage increases which have been negotiated in some major textile concentrations.

Claims of the industry were crosschecked with the experience in the National Textile Corporation and it was found that the escalation in prices was not justified by any means. I, therefore, held discussions with representatives of the textile industry in a meeting convened by me in Bombay on 10th March 1979. I urged upon the industry that they should take immediate steps for bringing down the prices of cotton cloth and cotton yarn.
