STATEMENT BY PRIME MINISTER RE. HIS PARTICIPATION IN THE COMMONWEALTH HEADS OF GO-VERNMENT REGIONAL MEETING HELD AT SYDNEY

THE PRIME MINISTER MORARJI DESAI): On the 17th of February I returned from the meeting of the Commonwealth Heads of Government of Asian and Pacific Region, which was held in Sydney for the first time. The initiative for this Conference was taken by Prime Minister Fraser of Australia at the Commonwealth Conference held in London last June. Even at that time, I had welcomed the proposal since I believed that a smaller regional meeting could be more useful and effective in initiating and pursuing plans for cooperation in a number of fields, mainly economic. We were glad to note that the Sydney meeting was attended by the Heads of Government of all the 12 countries in the region. I was accompanied by a delegation which included the Minister for External Affairs.

From India's point of view, the Conference served an important purpose in bringing together the leaders of the Commonwealth countries in the Asian and the Pacific region, some of them from small countries like Nauru, West Samoa and Tonga, with which we have not had close I also had a valuable contacts. opportunity to renew my acquaintance with President Ziaur Rahman of Bangladesh, President Jayawerdene of Sri Lanka, Prime Minister Lee Kuan Yew of Singapore, Prime
