SHRI S. M. BANERJEE (Kanpur): May I make a submission? I hope you will remember that in the Business Advisory Committee on two occasions some members, myself, Mrs. Godfrey and others had requested you to see that some sort of statement is made by the Health Minister on the various questions arising out of family planning. We are all for it. But there are reports from UP and other places that coercive methods are being used. All sorts of rumours are floated. They may be untrue. I am only requesting you to see that some sort of guideline is issued by the Centre which should be announced by the hon. Minister of Health or any other Minister. We welcome it so that we are able to combat the vicious campaign which has been started by certain interested agencies. I would request you to ask the Minister to make a statement clarifying the position of Government and giving confidence to the people that nothing is being done in a coercive manner.

SHRI DINEN BHATTACHARYA I fully support what (Serampore) : Shri S. M. Banerjee has said. I also requested you to accept a Call Attention notice on the bonus issue. This is an issue on which throughout the country there is some dissatisfaction and agitation among workers and employees. Some statement or some form of statement must come from Government as to what will happen to those workers who after working for one year are expecting that they would get something before Diwali. Puja or Onam I do not know what will happen. I do not know if this time they will be deprived of it. There is much dissatisfaction and throughout the country a 'day' has been observed by some trade union organisations. Therefore, I would request you, and through you, the Minister, to make a statement on this issue.
