## OBITUARY REFERENCES

Mr. DEPUTY-SPEAKER : 1 have to inform the House of the sad demise of two of our friends, Shri B. Narayanan and Shri Bhaskar Narayan Dighe.

Shri B. Narayanan was a sitting Member of this House representing Pollachi Constituency of Tamil Nadu. He was also a Member of the Fourth Lok Sabha during the years 1967-70. Shri Narayanan was one of the active Members of this house and used to take keen interest in the proceedings. He passed away at Willingdon Hospital last night at the young age of 46.

Shri Bhaskar Narayan Dighe was a Member of the Third Lok Sabha during the years 1962-67 representing Kolaba Constituency of Maharashtra. He took great interest in the co-operative movement and educational activities. He passed away at Bombay on the 23rd July, 1971, at the age of 54.

We deeply mourn the loss of these friends and 1 am sure the House will join me in conveying our condolences to the bergaved families.

THE PRIME MINISTER, MINISTER OF ATOMIC ENERGY, MINISTER OF HOME AFFAIRS AND MINISTER OF INFORMATION & BROADCASTING (SHRIMATI INDIRA GANDHI): Sir, the news of Shri B. Narayanan's death comes as a shock to us all, especially since he was only in his fortics and had before him so many years of service to the country.

Shri Narayanan was an active legislator, always an eloquent champion of the poor and oppressed. His amiability won friends for him from all sections of the Fourth and the present Lok Sabhas.

His death is a loss not only to the D.M.K. but to the entire House, Our sympathics go out to the bereaved family.

The Hon'ble Members are also grieved on the death of Shri Bhaskar Naravan Dighe. Those who were fellow Members in the Third Lok Sabha and his Party colleagues in Maharashtra remember Shri Dighe as a quiet and dedicated man. He took a prominent part in the Praja Parishad movement of the State of Janiira and was a respected leader of the Kolaba District of Maharashtra. He was interested in many fields of constructive work, such as Education, Adivasiuplift, Cooperation and Village Industries. In his death at la comparatively young age, we lose an earnest legislator.

He took an active part in the merger movement of that State, although his family had very cordial relations with the Nawab.

He was a staunch Congressman and was for some time the President of the Kolaba District Congress Committee. He was elected to the Maharashtra Legislative Assembly in 1952.

I had the honour to be his personal friend. During the last mid-term election he did considerable propaganda work for the New Congress, although he was in indifferent health.

Our district has become the poorer by his untimely death. I, therefore, condole his death.
