(a) what is the approximate requirement of fertilizers for the next year.

(b) what is the approximate production of fertilizers in India; and

(c) the steps taken by Government to fill up the deficit?

THE DEPUTY MINISTER IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI PRABHUDAS PATEL): (a) The agronomic requirenent of fertiliser nutrients for Kharif, 1975 and Rabi, 1975-76 has been assessed to be Rs. 45.88 lakh M. Ts. the break up of which in terms of N. P. & K. is as follows:--

(b) A quantity of 15.54 lakh M. Tonnes of Nitrogenous & 3.63 lakh M. Tonnes of phosphetic nutrients are likely to be proluced in the country during Kharif, 1975 und Rabi, 1975-76.

(c) The Government of India is making ill efforts to import the maximum possible juantity of fertilisers, to bridge the gap waven the requirement and domestic roduction of fertilisers. Efforts have also wen made to improve the distribution sysiem so that unduly large quantities of fertilisers do not remain in the pipeline. Steps have also been taken to supplement the use of chemical fertilisers, with the use of manutes and organic fertilisers.
