stated: "Shri Samar Guha began castigating Congress, the Chatra Parishad and the Yuva Congress. Irritated by his utterances some of the demonstrators surged towards the car".

The speeches attributed to me are totally incorrect fabricated and maliciously concocted to provide a camoudage to the unprovoked vandalism committed against JP, myself and others.

All Calcutta newspapers reported vividly what happened at the gate of the Institute on and April, 1975 and editorial comments were also made. But in no paper, it was reported anywhere that I made any speech or tried in any way to excite the Congress demonstrators by making any speech or disparaging remarks against any Congress leader. On the contrary, these papers mentioned how I was phycisally assaulted by the hooligans and may nose started bleeding in consequence.

On 3rd April, the Chief Minister of West Bengal, the Congress President and other Congress leaders and many Congress and CPI MLAs made vitriolic attacks on JP in trying to justify the anti-JP demonstration and praised the role played by the Congress demonstrators but none of them stated any where that I made any speech to exerte the Congress demonstrators during time of violent demonstration against JP.

I repeat that the statement made by the Home Minister, as part of the report sent to him by the Government of West Bengal, accusing me as playing the role of an instigator of violence, is perversly fabricated, politically motivated and malaciously concocted to cover up the omissions and commissions of the Government of West Bengal in not allowing the police to deal with the violent demonstration against JP and his supporters.

I urge the Home Minister to set up a Parilamentary Committee to inquire into the origin and the nature of the grisly incidents of April, 2, 1975.

THE MINISTER OF HOME AF-FAIRS (SHRI K. BRAHMANANDA REDDY): Sir, I have listened, with attention, to the statment made by Shri Samar Guha under Direction 115. He has referred to my earlier statement made on the Floor of the House on the 8th April, 1975, about the incidents in Calcutta during Shri Jayaparaksah Narayan's visit on 2nd April, He has specifically objected to the following portions of my statement:

"Tension, however, increased subscquently due to counter demonstration by the followers of Nav Nirman Samity and the speeches given by Shri Samar Guha, M. P.... Shri Samar Guha, MP made the following remarks, 'Goondaism is going on under the direction of Indira Gandhi. Indira Gandhi and her favourite Chief Minister are leaders of goonda gang's....Shri Samar Guha, MP then climbed on the bonnet of the car and began castigating the Congress, the Chhatra Parishad and the Yuba Congress. Irritated by this utterances, some of the demonstrators surged towards the car

I had made my statements based on the information furnished by the State Government and had, in fact, quoted verbatim from their reports regarding the remarks attributed to Shri Samar Guha. On receiving information that the Speaker has permitted Shri Samar Guha to raise the matter in the House under Direction 115, we checked the matter again with the State Government and they have reiterated their earlier report. I, therefore, submit, Sir, that there has been no mistake or inaccuracy in sharing with the House the information funished by the State Government.

Shri Samar Guha has said that the Home Minister wholly disbelieved him and accepted the report of the West Bengal Government as correct. It is not a question of our believing or disbelieving Shri Samar Guha. Law and order is primary the concern of the State Government. It has been our convention and practice to rely on the reports from the State Governments while giving information to the Hon'ble Members of this House about law and order incidents.
