STATEMENT RE HELICOPTER ACCIDENT IN THE BOMBAY HIGH

THE MINISTER OF PETROLEUM (SHRI K. MALAVIYA): Mr. D Speaker Sir, it is with deep regret that I rise to make this statement regarding an accident that occurred on the afternoon of Friday, the 9th of January. As the Honourable bers are aware, ONGC has been exploring for petroleum in the Bombay High area Apart from its own rig, the Sagar Samrat, ONGC has charter-hired two rigs namely, the Haakon Magnas and the Dalmahoy The periodical crew-change on the rigs is effected with helicopter services provided by the Indian Air Force

On 9th January, a helicopter landed on the Haakon Magnus and after the relieving crew disembarked, it flew on to the Dalmahoy and picked up six persons from that rig. While returning to the Haakon Magnus around 15 32 hours to pick up the relieved crew, the tail-rotor of the helicopter appears to have struck against some part of the drill ship, caught fire; as the helicopter landed on the helipad there was an explosion

The helicopter crew came out with minor injuries. Of the six passengers, Mr Mike Ryan, a French potional working with schlumberger, was thrown out of the helicopter in a State of severe shock. The other five passengers died instantaneously and their hodies were recovered. Among those killed was a Canadian employee of a firm of Singapore engaged in the cementing work of oil wells; and four were Indians, of whom one was a Senior Driller of the O.NGC., and three were Indian employees foreign contracting firms

On receipt of the information, a rescue helicopter was immediately flown out. The helipad of the Haakon Magnus having become unserviceable due to the accident, the rescue heli-
