**CORRECTION OF ANSWER TO S. Q
NO. 902 RE. INDIAN SPACE VIOLA
TIONS BY PAK. HELICOPTERS IN
KASHMIR**

**ISTRY OF DEFENCE (SHRI VIDYA
CHARAN SHUKLA):** Mr. Speaker, Sir, while answering one of the supplementary questions, arising out of Starred Question No. 902 on 19th May, 1972, I had stated that the Pakistani helicopter which violated Indian air space near Jammu on 16th March, 1972 had intruded 100 yards. On further checking, I find that the helicopter penetrated $3\frac{1}{2}$ NM of Indian air space.

The delay in making this correction statement has occurred because the inaccuracy came to notice only at the end of August, 1972 when material had been collected for fulfilling the assurance given in reply to the same supplementary question and because the House adjourned *sine die* soon thereafter.

I had also promised, in reply to the same supplementary question, to supply information to the House about the details of 9 cases of intrusions by Pakistani aircraft subsequent to 17th December, 1971 (1 in Jammu and Kashmir, 4 in Punjab and 4 in Rajasthan). These details are given in the Statement laid on the Table of the House.
